Articles of Organization**

Article I

The name of the Limited Liability Company: **HarHad Companies, LLC**

Article II

The duration of the Limited Liability Company is **perpetual**.

Article III

The Limited Liability Company has been organized for the following purposes:

1. To acquire, manage, maintain, and care for Gallery24seven.com, LLC (hereinafter referred to as "the Company") property. For purposes of these Articles, the "Company property" is defined as the real, intellectual and personal property currently owned by the Company or purchased by the Company at a future date.
2. To fix, levy, collect, and enforce payment by any lawful means of all monies due to the Company pursuant to the terms of any Lease or Contract on property; to pay all expenses in connection therewith and all office and other expenses incident to the conduct of the business of the Company, including all licenses, taxes, or governmental charges levied or imposed against the Company.
3. To take, lease, purchase, or otherwise acquire, and to own, use, hold, sell, convey, exchange, hire, lease, pledge, mortgage, and otherwise deal in and dispose of such personal property, chattels real, rights, easements, privileges, choses in action, notes, bonds, mortgages, and securities as may be lawfully acquired, held, or disposed of by it under the laws of the State of Alabama.
4. To erect, construct, maintain, improve, rebuild, enlarge, alter, and manage and control, directly or through ownership of stock in any corporation, any and all kinds of buildings, houses, stores, offices, shops and any and all other structures and erections which may be in the judgement of the Company's Board of Directors at any time necessary, useful or advantageous

for the purpose of the company, and which can lawfully be done under the laws of the State of Alabama.

5. To borrow money, mortgage, pledge, deed in trust, or hypothecate any or all of the Company property as security for money borrowed or debts incurred.
6. To make and perform contracts of every kind and description, including contracts hiring employees, consultants, managers, attorneys, accountants and the like to assist in the operation and/or management of the Company property, and in carrying on its business or for the purpose of attaining and furthering any of its objects, to do any and all things which a natural person might or could do, and which now or hereafter may be authorized by law, and in general to do and perform such acts and things and transact such business in connection with the foregoing objects, not inconsistent with law, as may be necessary and/or desirable for the benefit of the Company.
7. To conduct Company business, carry on its operations, and have and exercise the powers granted by Title 10, Article 12, Code of Alabama, 1975, in any State, territory, district, or possession of the United States of America, or in any foreign country;
8. To make and alter an Operating Agreement, not inconsistent with these Articles of Organization, or with the laws of Alabama, for the administration and regulation of the affairs of the Company.
9. To cease Company activities and wind up Company affairs in accordance with the provisions of the Operating Agreement, or if no provision addresses this matter, then in accordance with Title 10, Article 12 of the Code of Alabama, 1975.

Article IV

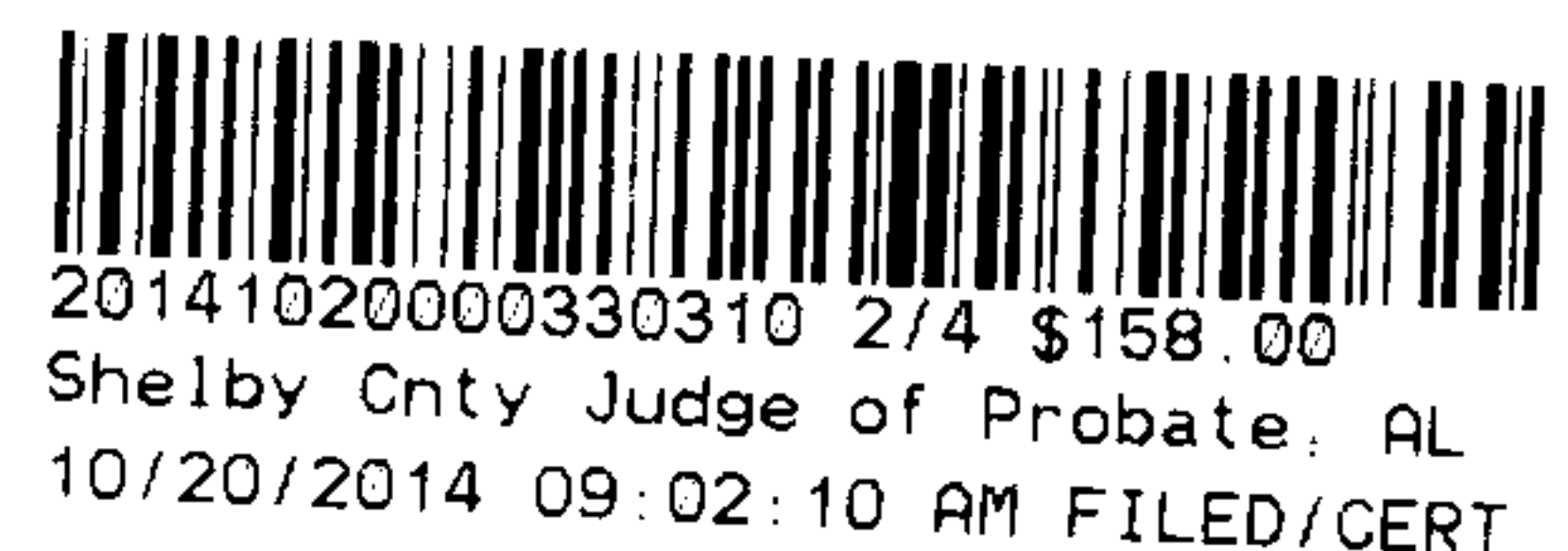

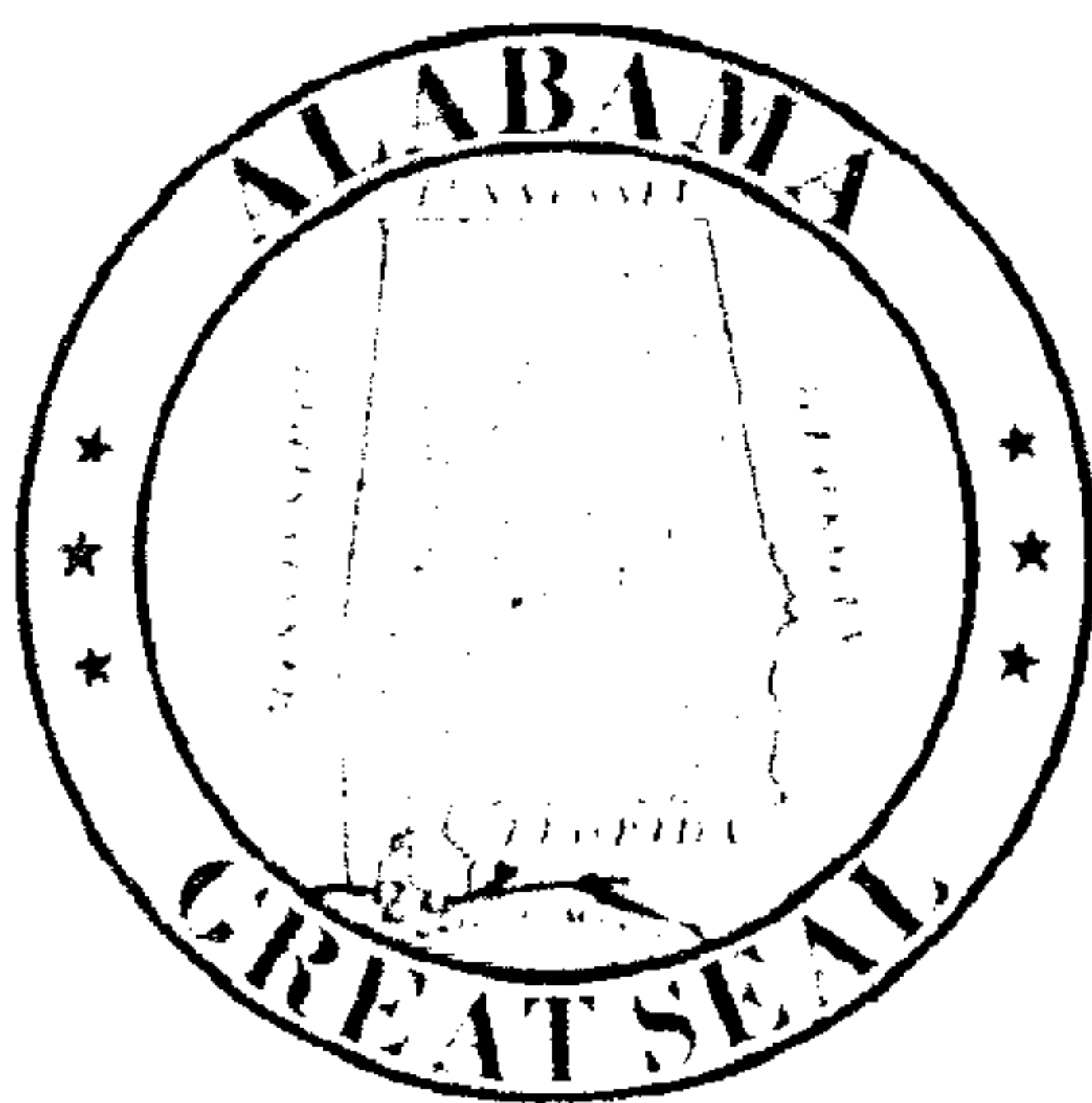
