KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 11th day of October, 2002, Billie Knighten Driver aka Billie Knighten Drive, an unmarried woman, executed that certain mortgage on real property hereinafter described to Wells Fargo Home Mortgage, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20080124000031450 and corrected by Order recorded in Instrument No. 20140911000285440, said mortgage having subsequently been transferred and assigned to Wells Fargo Bank, N.A., successor by merger to Wells Fargo Home Mortgage, Inc., by instrument recorded in Instrument Number 20110318000087530, in the aforesaid Probate Office ("Mortgagee"); and

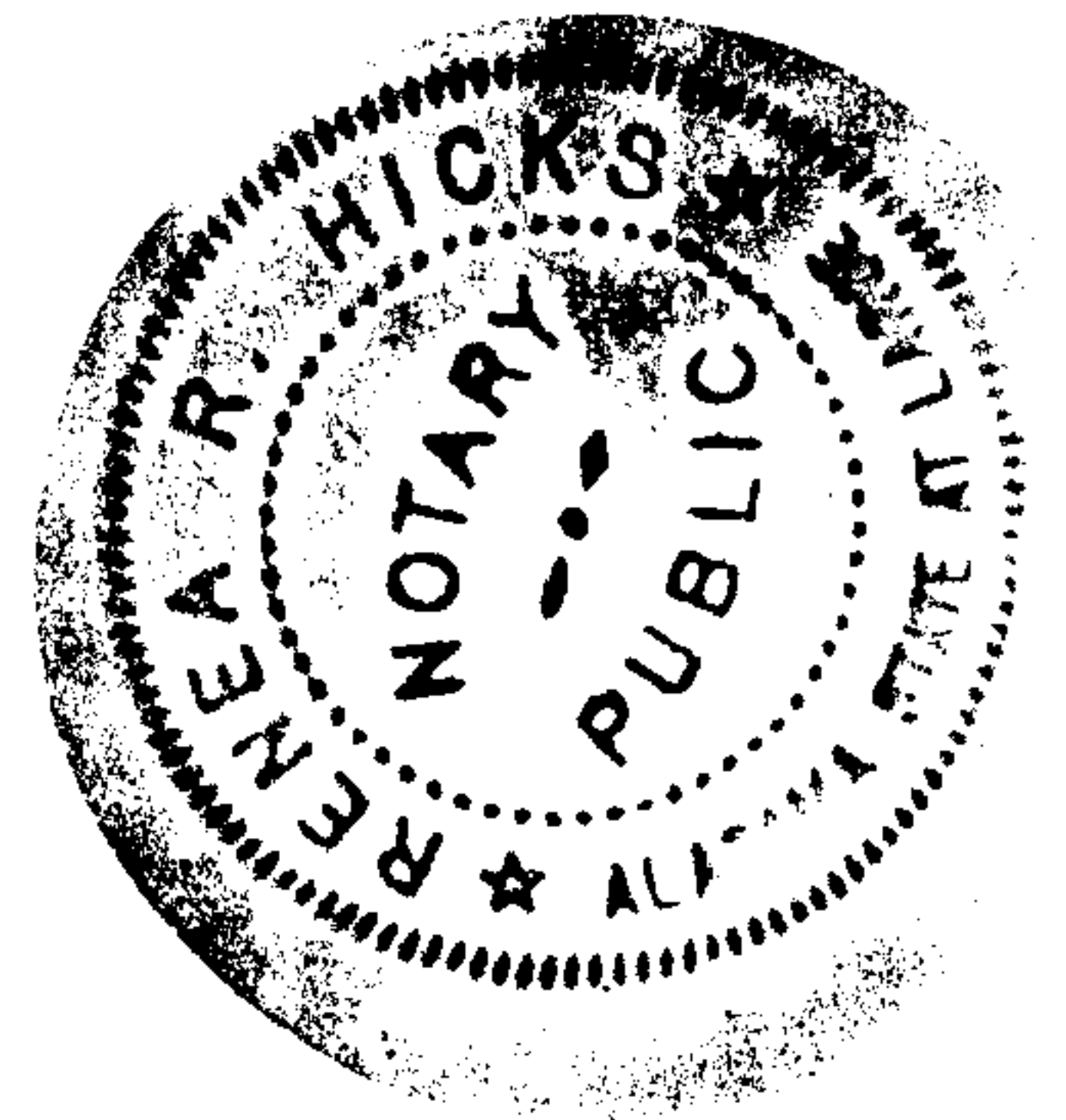

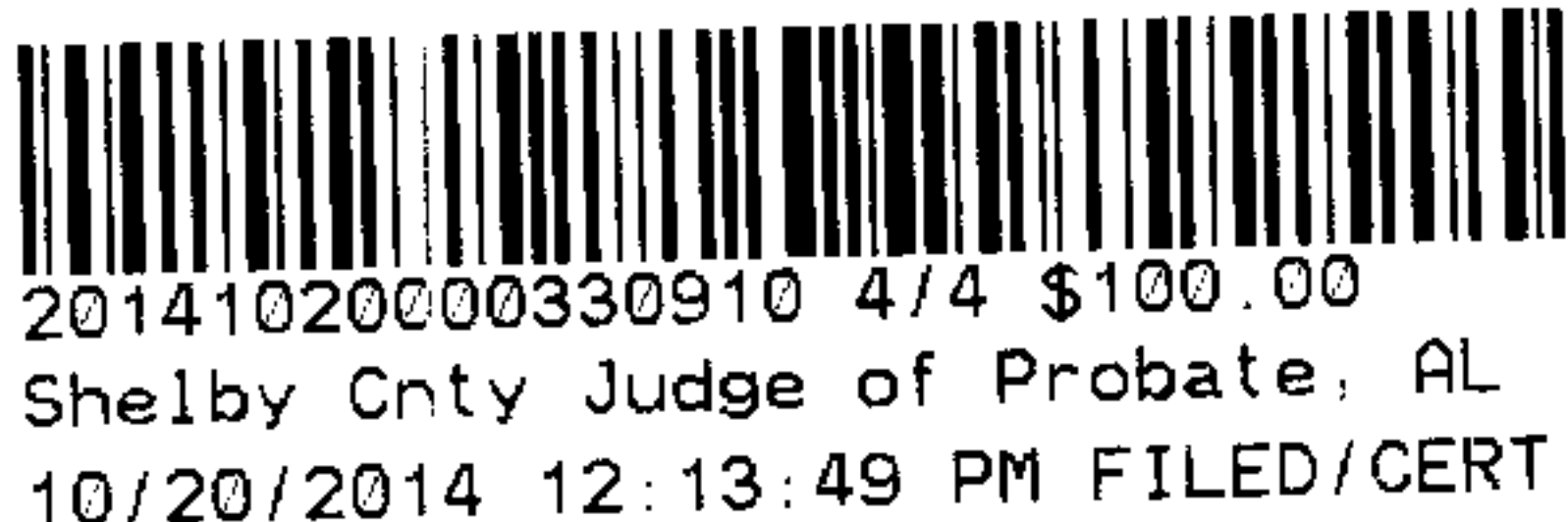
