JUDGMENT BY CONSENT

As a part of the settlement, and in exchange for the consideration paid to Plaintiff/Counterclaim-Defendant in the Settlement and Release Agreement, the parties have consented to the entry of the following judgment. It is, therefore,

ORDERED, ADJUDGED and DECREED by the Court as follows:

1. The following documents recorded in the Probate Office of Shelby County, Alabama, are declared invalid, void, and of no force or effect:

A. Quit Claim Deed dated October 12, 2004, from Eugene E. Shirley and Anna Grace Shirley to The Eugene E. Shirley and Anna Grace Shirley Revocable Living Trust, recorded as Instrument # 20041015000569840.

B. Quitclaim Deed dated November 14, 2012, from Anna Grace Shirley, individually and as sole surviving Trustee of the Eugene E. Shirley and Anna Grace Shirley

Revocable Living Trust to Anna Grace Shirley and John Michiel Fortenberry, recorded as Instrument # 20121114000437640.

C. Statutory Warranty Deed dated January 18, 2013, from Sharon S. Gilmore as Trustee of The Eugene E. Shirley Revocable Living Trust, recorded as Instrument # 20130125000033730.

A copy of this judgment shall be recorded in the real property records in the Probate Court of Shelby County, Alabama, and shall be indexed to refer to the names of all the parties in the documents referred to above.



3. Except as otherwise provided in the Settlement and Release Agreement signed by the parties, all other relief claimed in either the Complaint or the Counterclaim is denied.


4. Costs are taxed as paid.
