

ARTICLES OF ORGANIZATION

OF

ARTICLE I

Name

ARTICLE VII

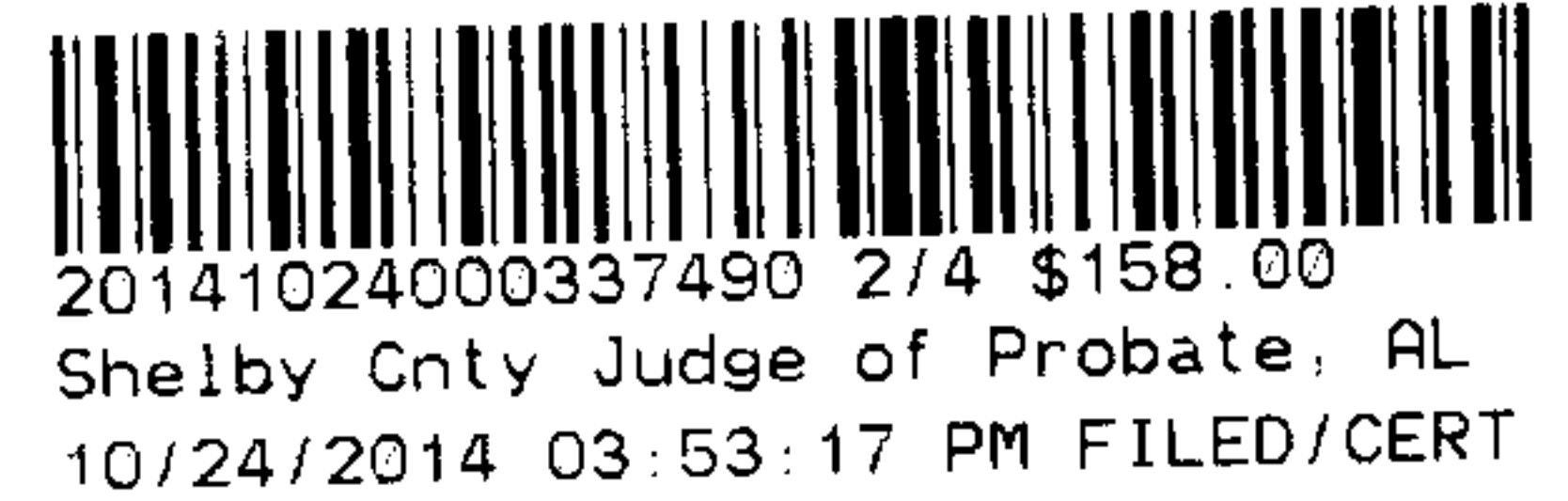
Continuation of Business
