



ARTICLES OF ORGANIZATION

ARTICLE I

Name

Registered Office; Registered Agent

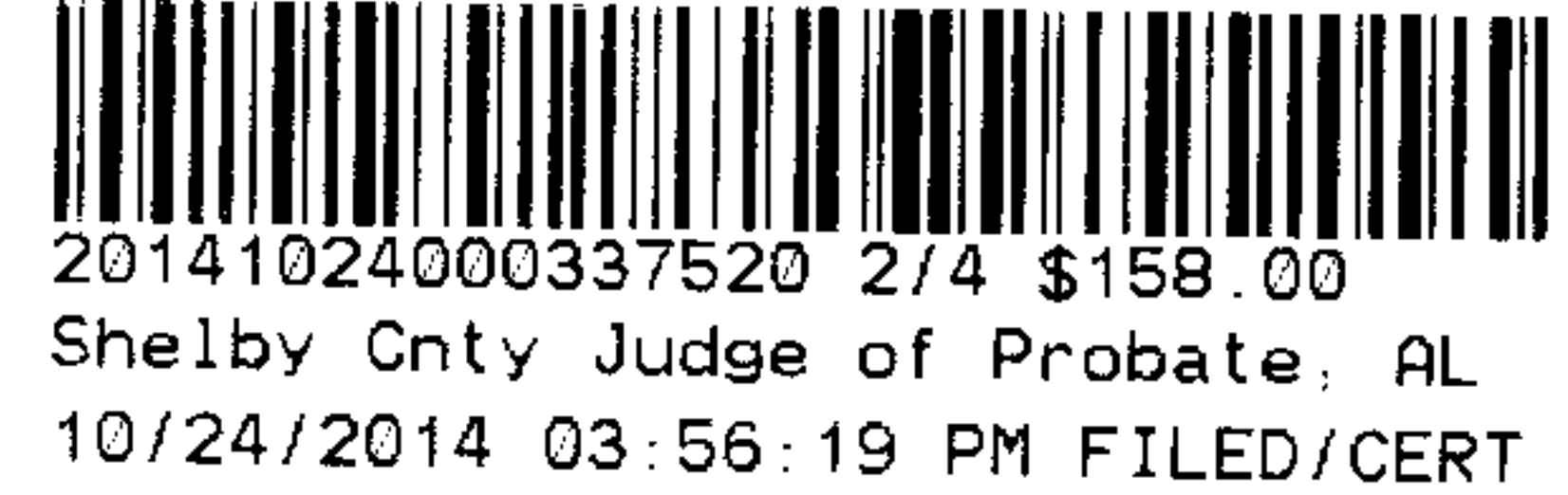
