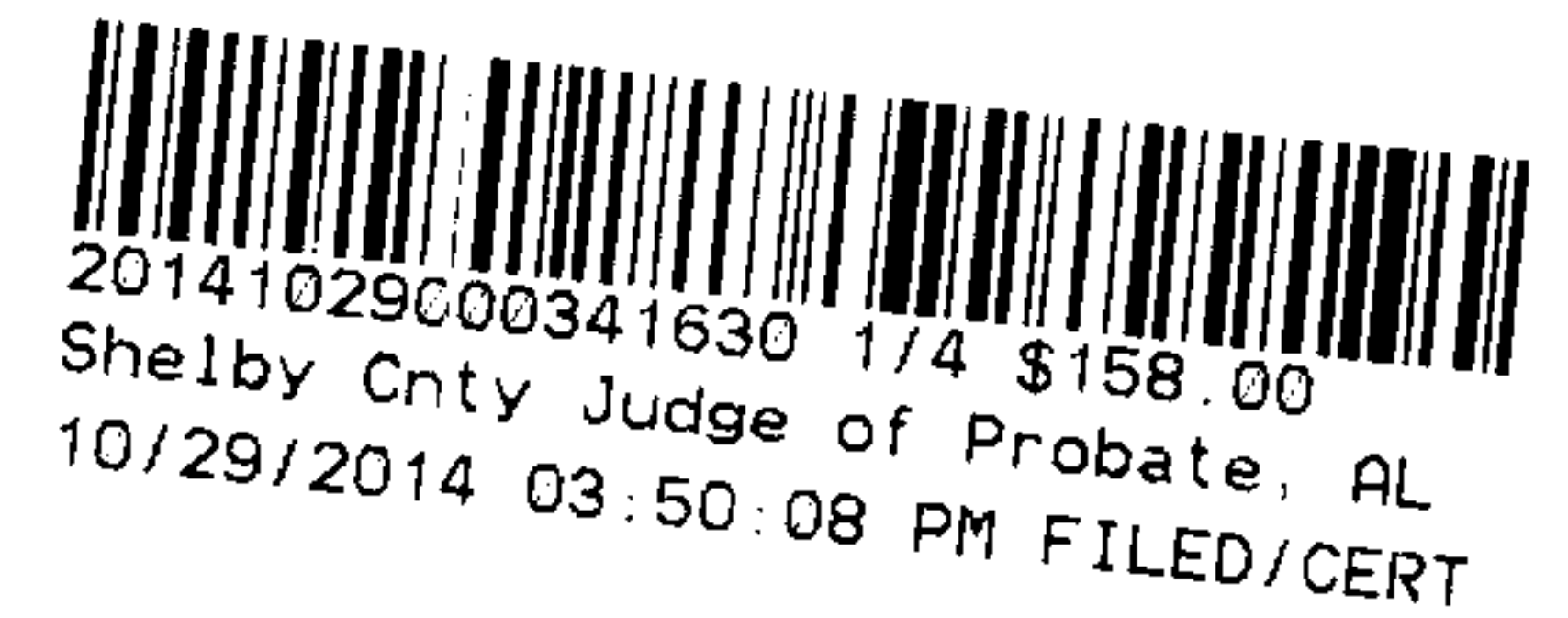

ARTICLES OF ORGANIZATION

OF

4 STORYS, LLC



**To the Honorable Judge of Probate in and for Shelby County,
Alabama:**

The undersigned, acting as Organizer of a limited liability company under the Alabama Limited Liability Company Act, hereby adopt the following Articles of Organization for 4STORYS, LLC.

FIRST: The name of the company is 4STORYS, LLC.

SECOND: The Company shall continue in existence until it is dissolved in accordance with the provisions of the operating agreement, or, if there is no operating agreement or no provision in the operating agreement governing the duration of the Company, then in accordance with the Alabama Limited Liability Company Act, or other applicable laws.

THIRD: The Company is organized for the purpose of engaging in the business of installation of counter tops, tile, cabinets and any other products related to homebuilding and construction. To that end the Company shall possess all the powers necessary to conduct a business and to carry out the objects expressed herein, together with all of those powers expressly conferred upon Limited Liability Companies or enumerated in Title 10 of the Code of Alabama, 1975, as last amended. The corporation shall also have all powers bestowed upon Limited Liability Companies

under any of the laws of the State of Alabama, as well as those necessarily implied.

FOURTH: The mailing address of the initial registered office of the Company is P O Box 1792, Alabaster, Alabama, 35007, and the name of the initial registered agent at such address is Christopher Perry Story.

FIFTH: The names and addresses of the initial members of the Company are:

SIXTH: The initial members of the Company may admit additional members at such times and upon such terms and conditions as may be agreed by the Company and the additional members.

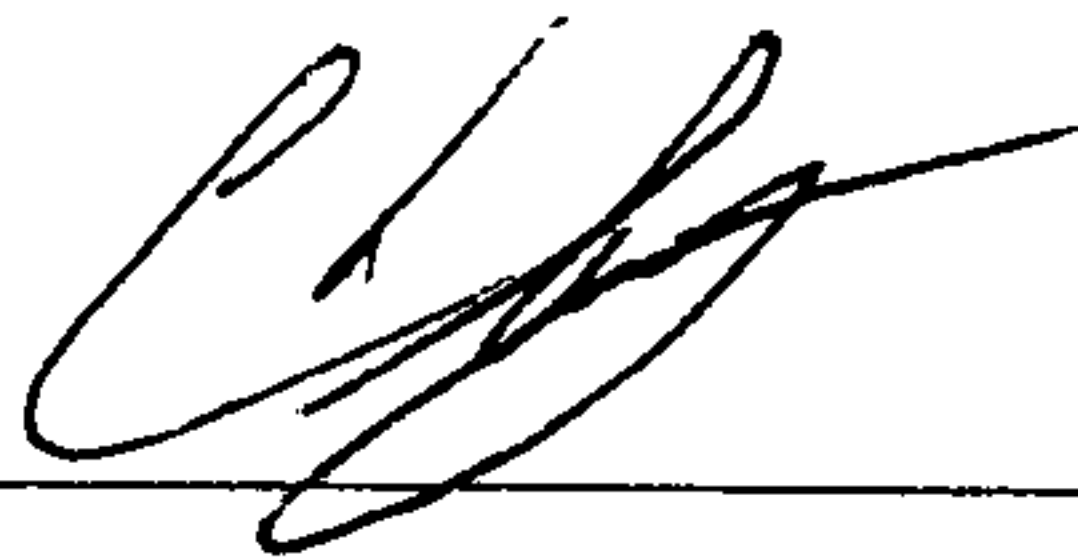
SEVENTH: The legal existence and business of the Company may be continued by the written consent of all the remaining members within 90 days after an event of disassociation of a member.
