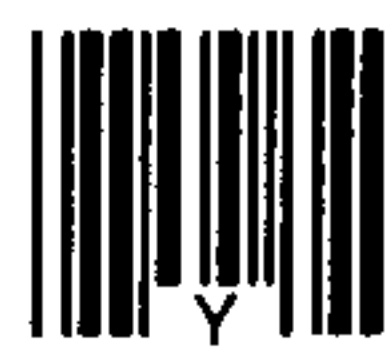
FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 30th day of April, 1998, Teresa Wilson, a single person, executed that certain mortgage on real property hereinafter described to Household Finance Corporation of Alabama, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 1998-16820, said mortgage having subsequently been transferred and assigned to Bank of America, N.A., by instrument recorded in , in the aforesaid Probate Office ("Transferee"); and

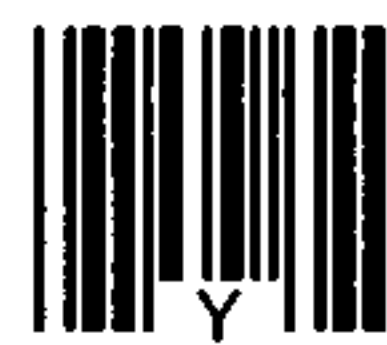

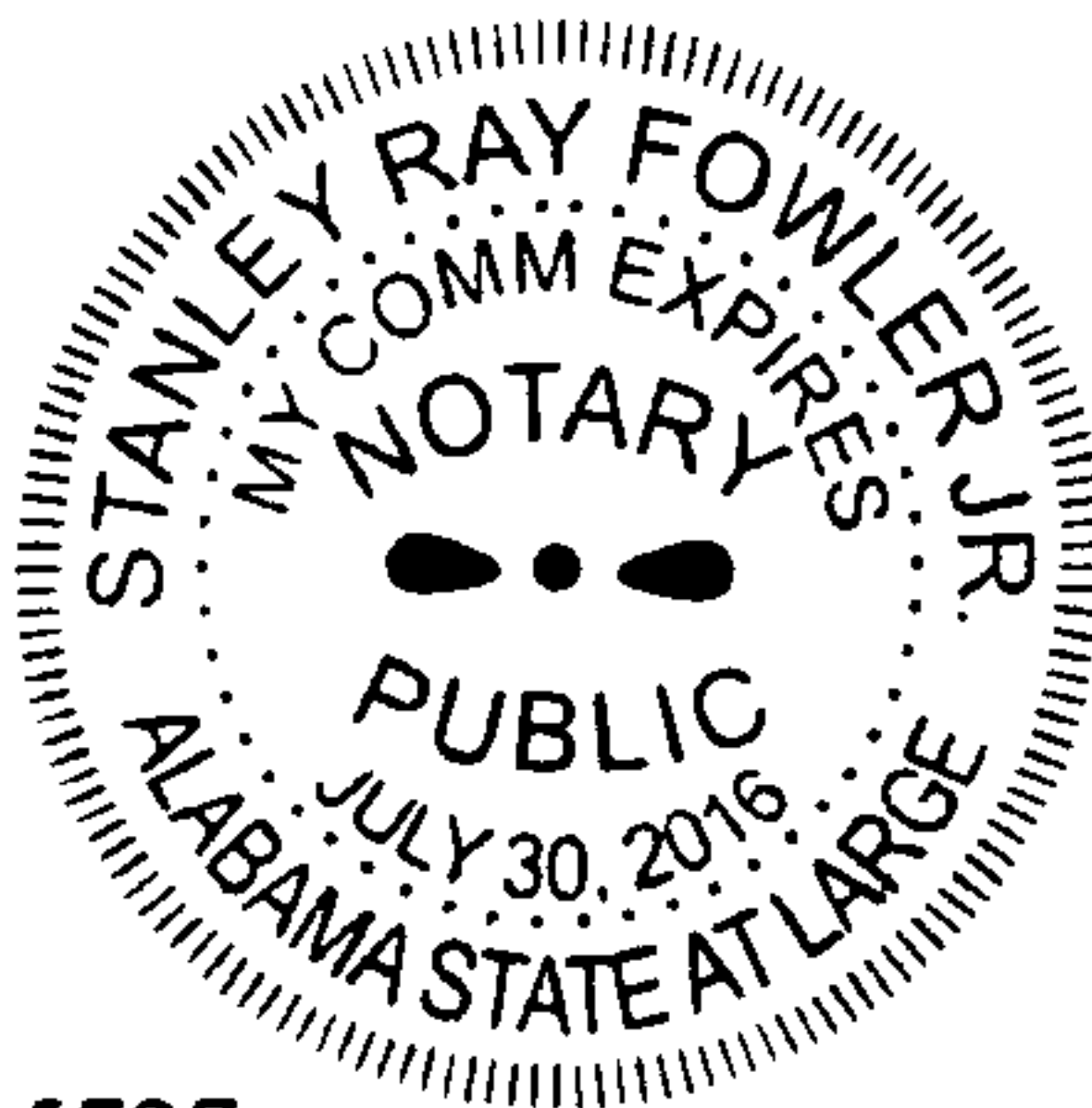
