ADDITIONAL MEMBERS

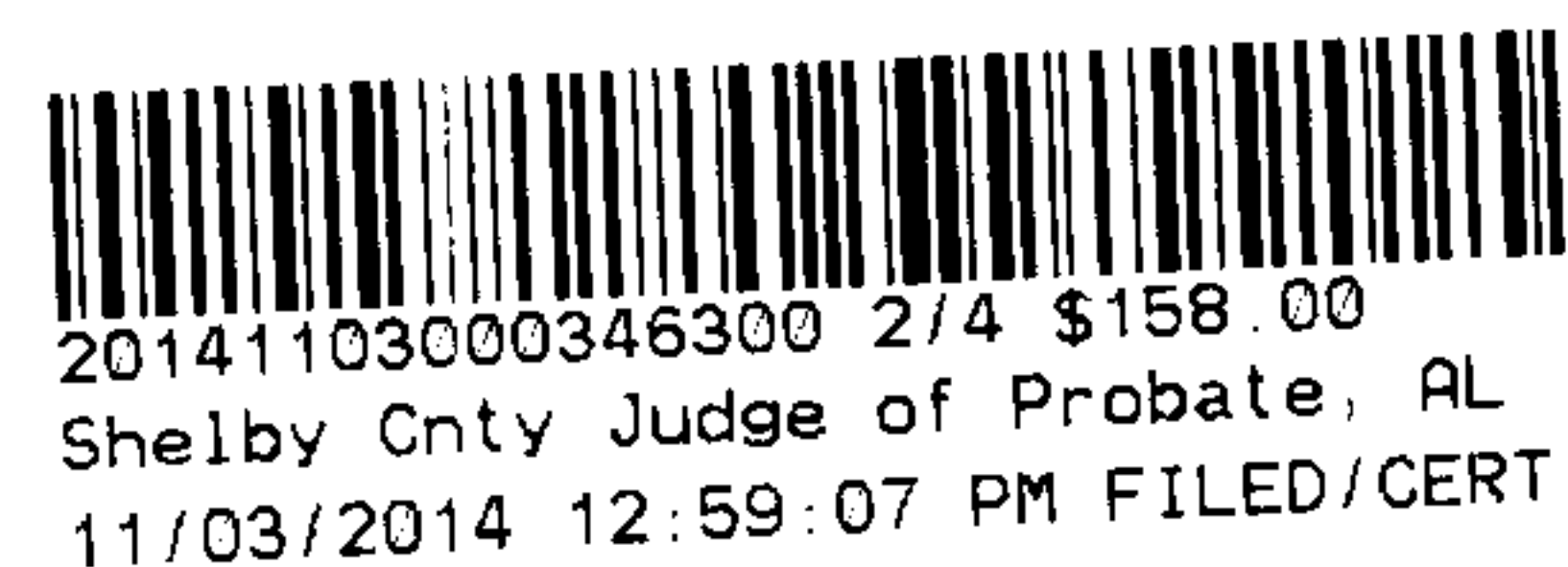
No additional members shall be admitted as members of this limited liability company, without the unanimous consent of all members.
