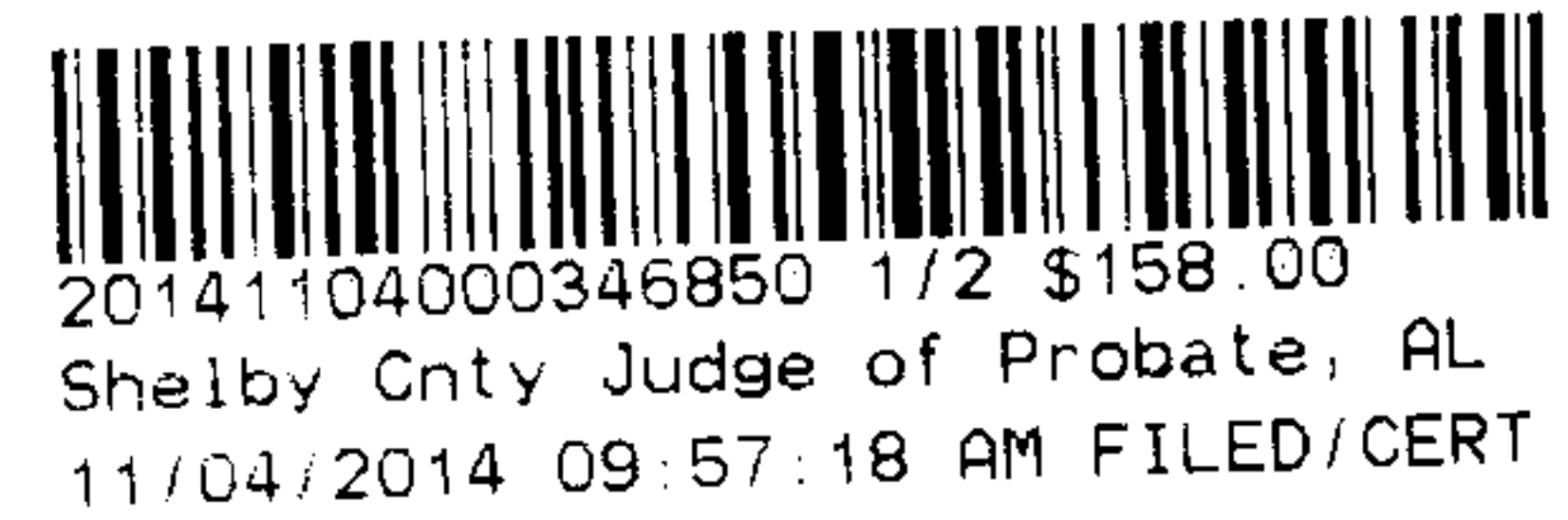


CONSENT OF ALL SHAREHOLDERS

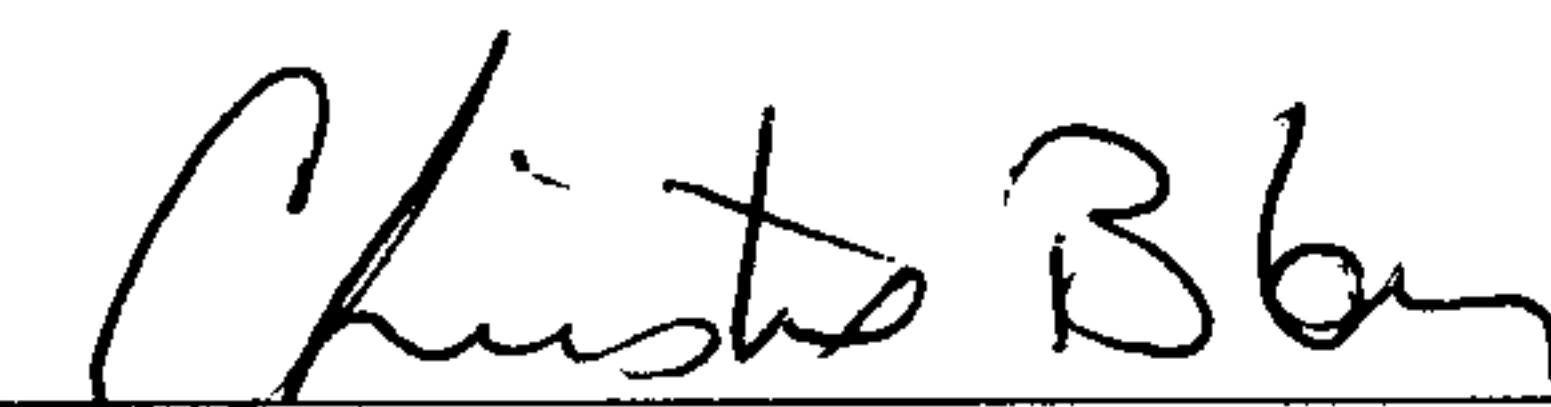
