

ARTICLES OF ORGANIZATION OF DYCO TRUCKING & LOGISTIC, LLC

Pursuant to the Provisions of Act No. 93-724 of the 1993 Alabama Legislature, the undersigned hereby adopt the following Limited Liability Company Articles of Organization.

ARTICLE I

NAME

The name of the limited liability company is Dyco Trucking & Logistics, LLC.
(The "Company").

ARTICLE II

DURATION

The period of its duration is thirty (30) years, provided that the company shall cease to exist upon dissolution of the Company in accordance with section 37 of the Alabama Limited Liability Company Act.

ARTICLE III

PURPOSES

The purpose for which the Company has been organized is the transaction of any and all lawful business for which a limited liability company may be organized under the Alabama Limited Liability Company Act, including, without limitation, the transportation of goods and materials, and to do everything necessary, proper, advisable or convenient for the accomplishment of the foregoing purpose.

RIGHT TO CONTINUE BUSINESS

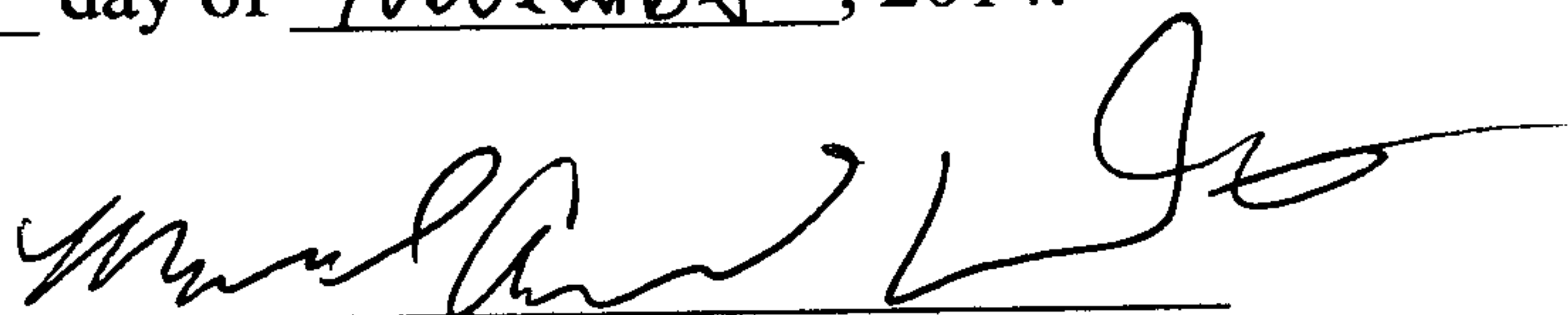
The Company shall be dissolved and shall commence winding up its affairs upon the first to occur of the expiration of the term of the Company, or in accordance with the Act.

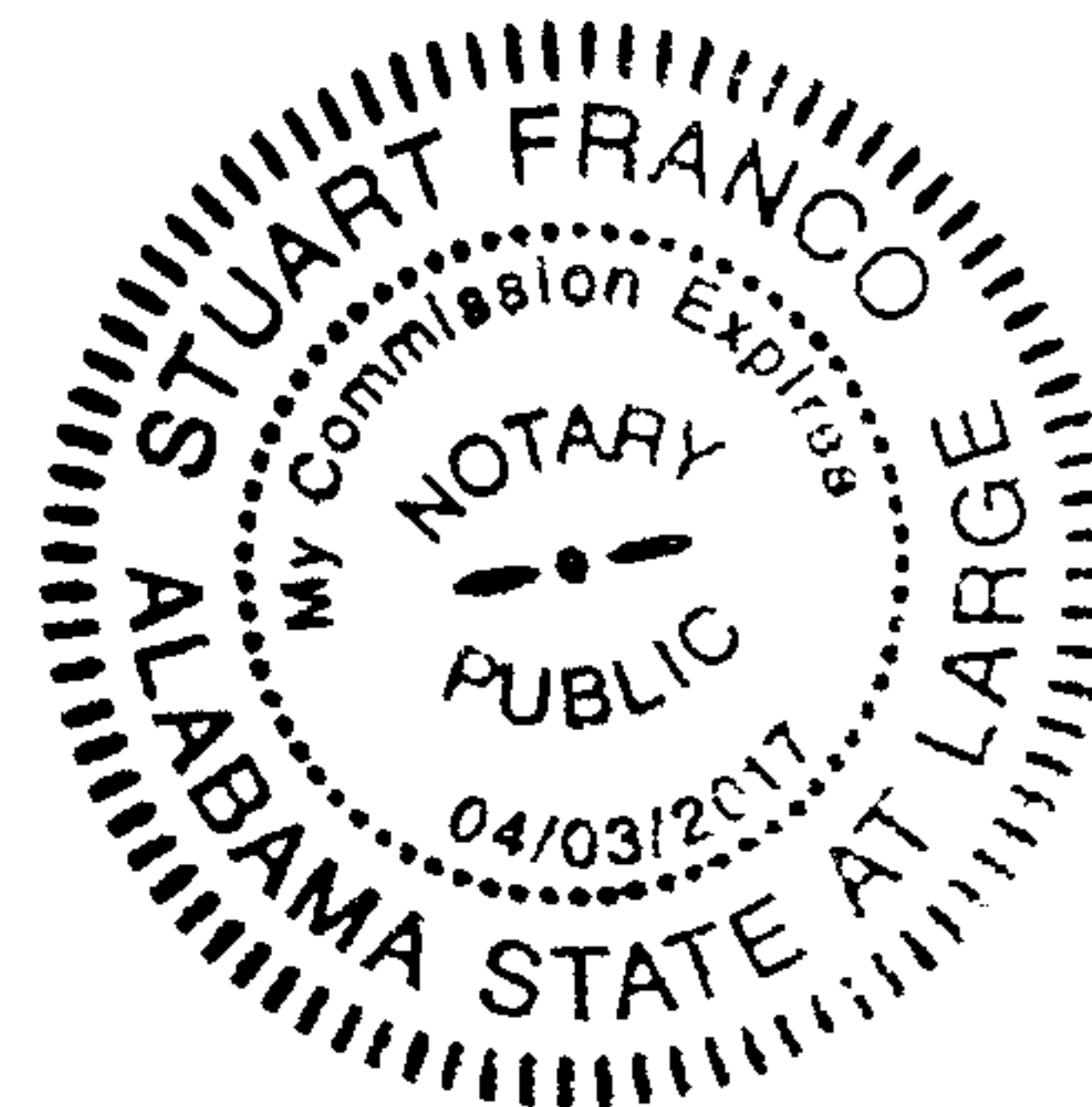

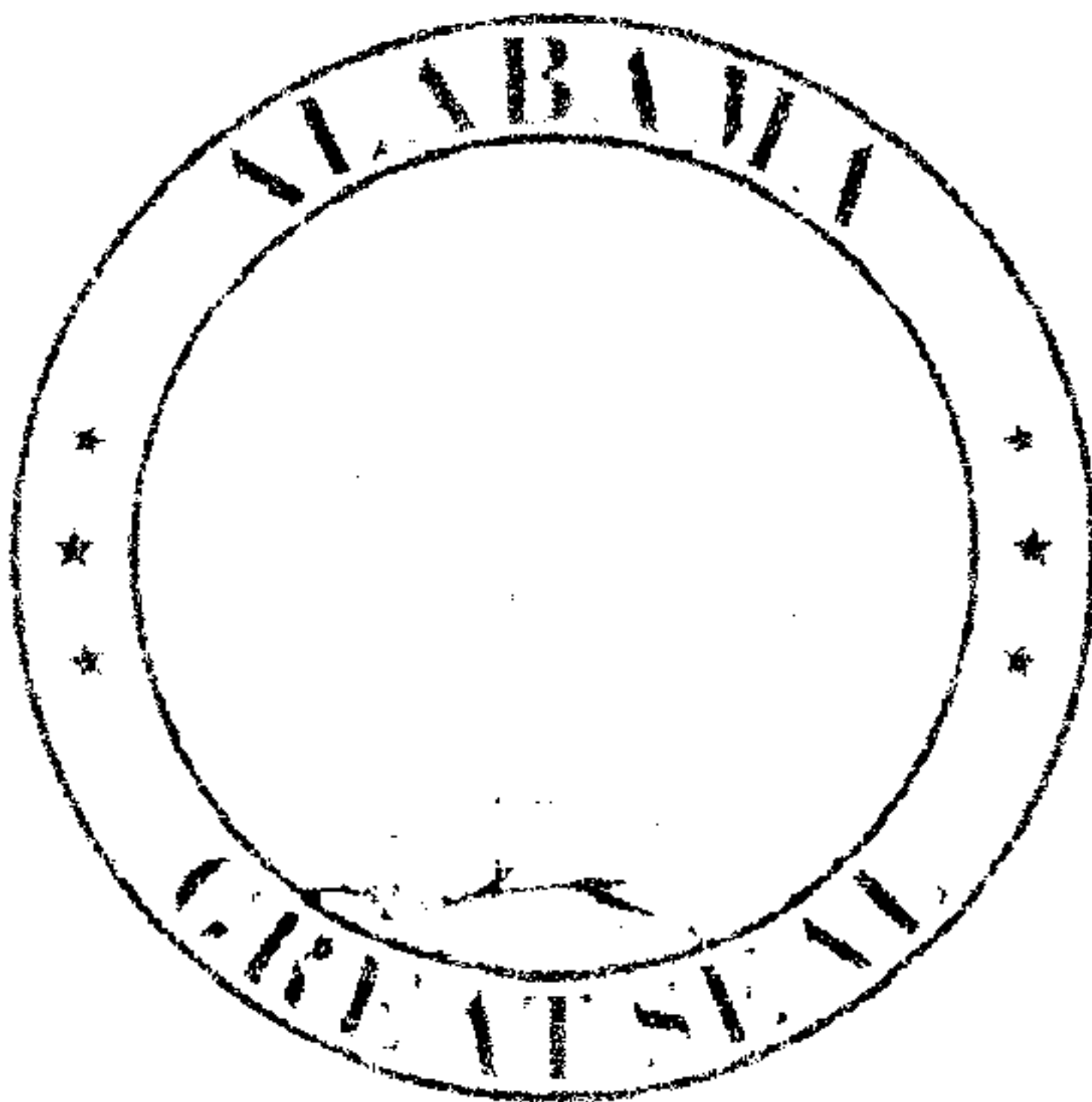
