KNOW ALL MEN BY THESE PRESENTS: That I/we,

This instrument is executed and delivered in the State of Alabama, and the laws of the State of Alabama shall govern all questions as to the validity of the power and the construction of its provisions.

4. **THIRD PARTY RELIANCE:** Third parties may rely upon the Representatives of my Agent as to all matters relating to the specific power granted to my Agent




