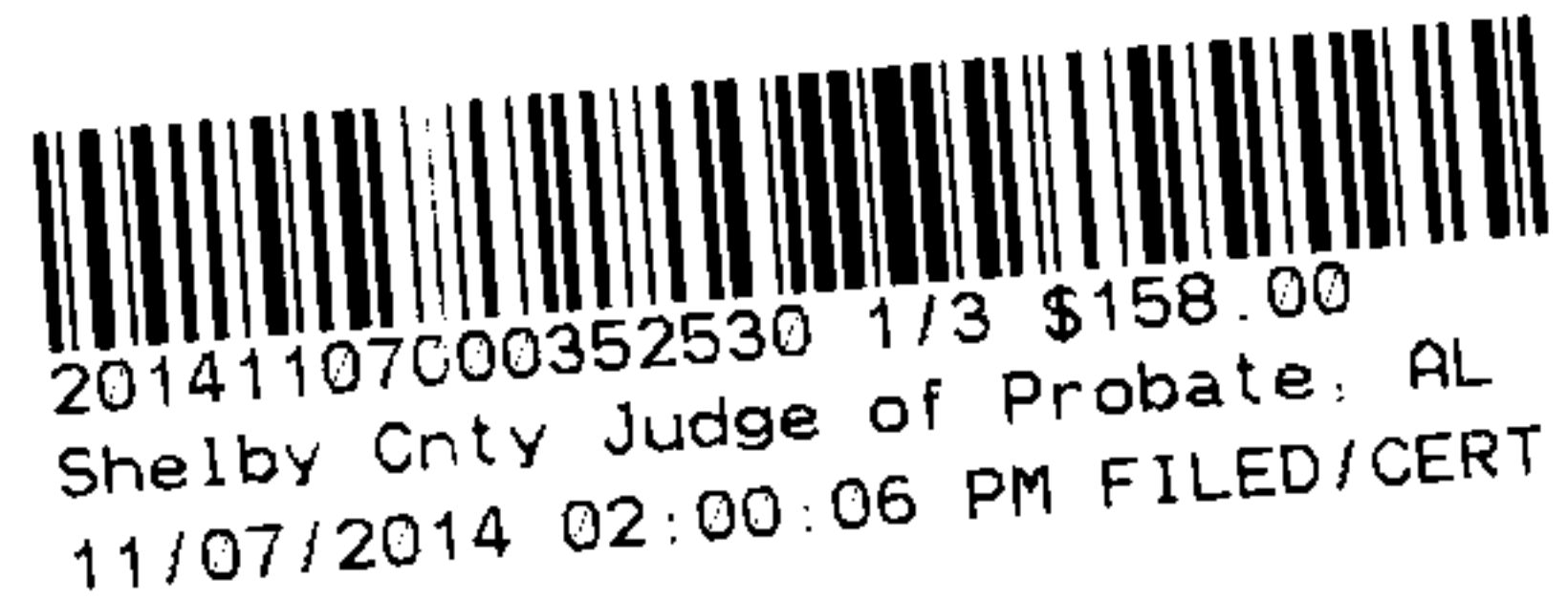

**ARTICLES OF ORGANIZATION
OF
MDS INVESTMENTS, LLC**

The undersigned organizer, desiring to form a limited liability company pursuant to the laws of the State of Alabama, hereby certifies as follows:

1. **Name.** The name of the entity is MDS Investments, LLC.
2. **Type of Entity.** The type of entity being formed is a limited liability company.
3. **Purpose.** The purpose for which this limited liability company is organized is to engage in the transaction of any and all lawful business for which limited liability companies may be organized under the laws of the State of Alabama.
4. **Duration.** The existence of the limited liability company shall commence on the date of the filing of these Articles of Organization in the Office of the Judge of Probate of Franklin County, Alabama, and its duration shall be perpetual; provided, however, that the limited liability company shall be dissolved (a) upon the written consent of all of the members; (b) as provided in the Operating Agreement; or (c) as may be required by the Alabama Limited Liability Company Law.
5. **Registered Agent and Registered Office.** The location and mailing address of the initial registered office shall be 718 Fulton Springs Road, Alabaster, Alabama 35007, and the name of the initial registered agent at said address shall be David Allen Abroms.
6. **Initial Members.** The names and mailing addresses of the initial members of the limited liability company are as follows:

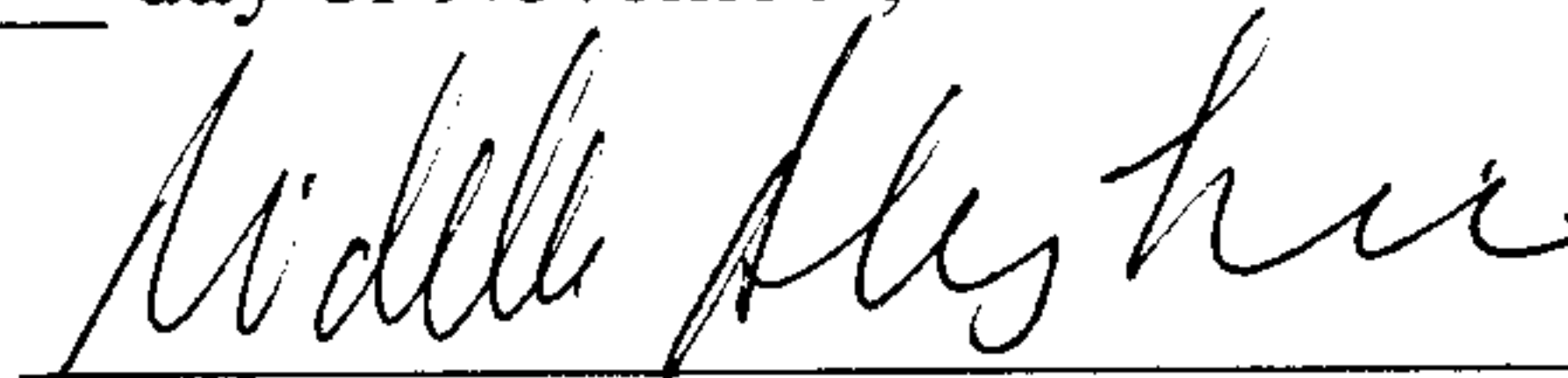
