

**ARTICLES OF ORGANIZATION OF  
ACLD, LLC**

Pursuant to the Provisions of Section 10-12-1, *et seq.* of the Code of Alabama (1975), the undersigned hereby adopt the following Limited Liability Company Articles of Organization.

**ARTICLE I**

The name of the limited liability company is ACLD, LLC (the “Company”).

**ARTICLE II**

The Company shall have perpetual duration from the date of organization unless it is dissolved and its affairs wound up prior to that date in accordance with the Alabama Limited Liability Company Act (the “Act”).

**ARTICLE III**

The purposes for which the Company is formed are:

- (a) To provide custom lighting and design materials and service;
- (b) To engage in any other lawful business of any kind or character whatsoever as the Member(s) should decide is prudent and in the best interest of the Company; and
- (c) To engage in any other lawful act or activity necessary or beneficial for the operation of the business.

**ARTICLE IV**



The initial Member of the Company shall be Southeastern Clinics, LLC.




ARTICLE VII


