AND, WHEREAS, the Grantee has today advanced and loaned to the Grantor the additional sum of Sixteen thousand nine hundred Dollars under the provisions of said deed to secure debt, and on security thereof, which advance is evidenced by a note made by Grantor to the Grantee for the sum of Sixteen thousand nine hundred Dollars, dated August 29, 2005, and bearing interest at the rate of eighty-two & 50/100 7.00% percent per annum from date, and payable in regular monthly installments of Two hundred thirty-four & 29/100 Dollars each, beginning with the first installment payable on September 28, 2005 and continuing with a like installment on the 28th day of every month thereafter until said note is paid in full; it being further provided that the entire principal and interest of said note, if not sooner paid shall be due on the 28th day of August, ~~19~~ 2010.

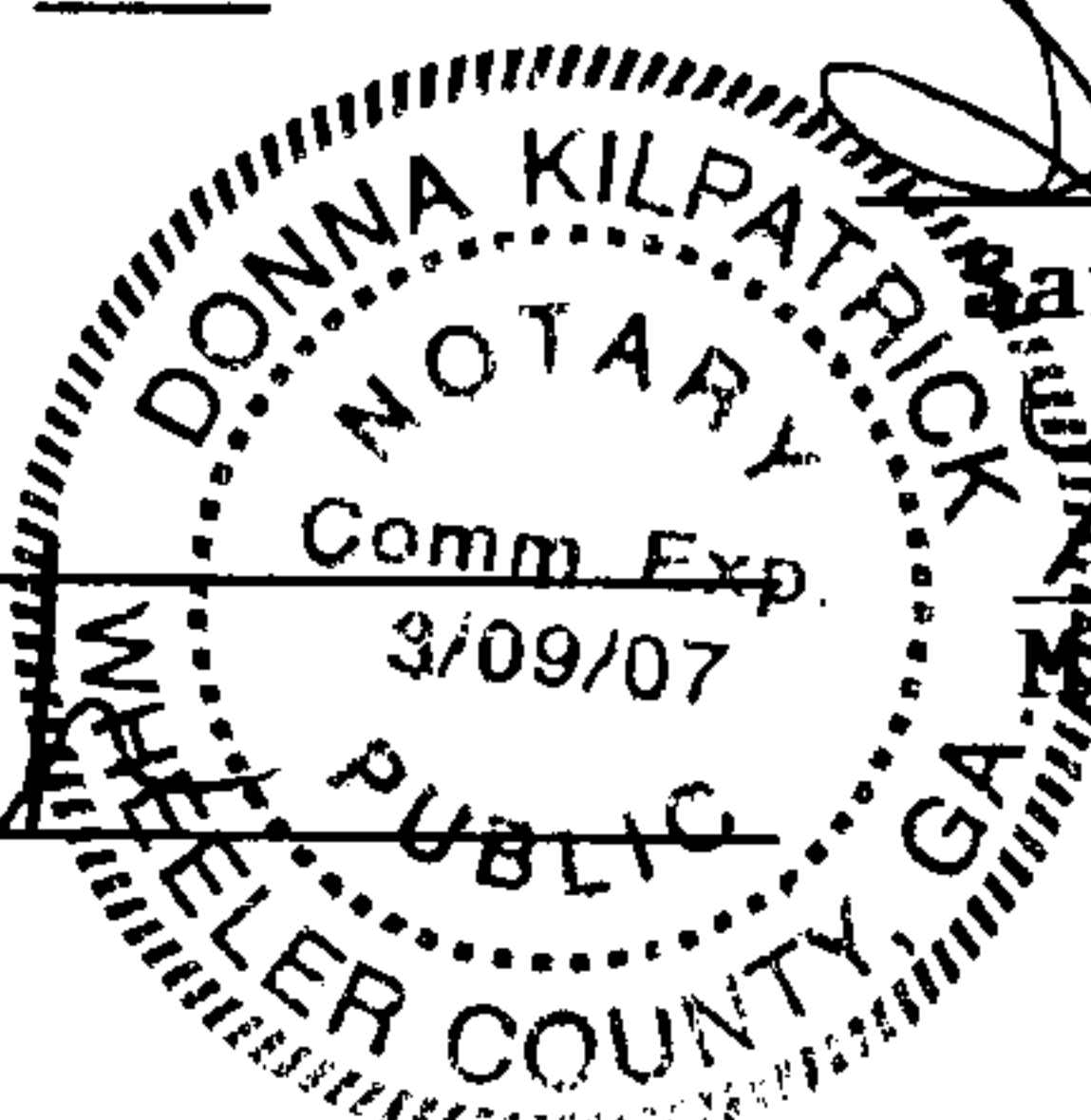
