WHEREAS, heretofore, on, to-wit: the 26th day of June, 2009, Teresa A. 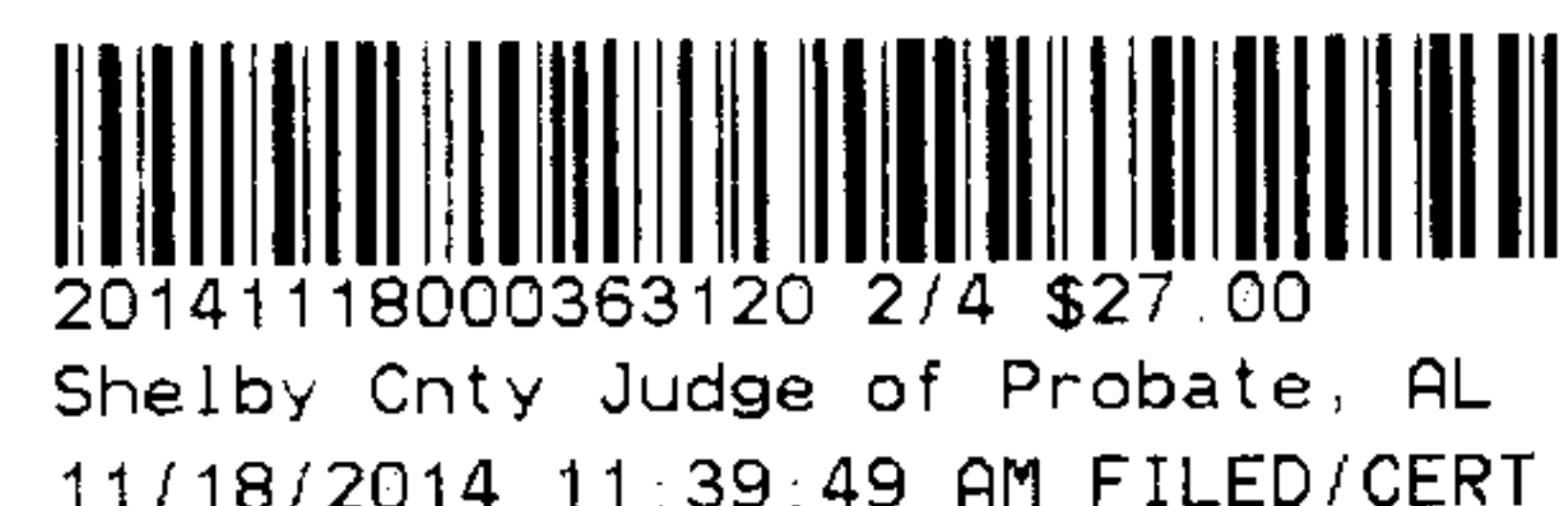
