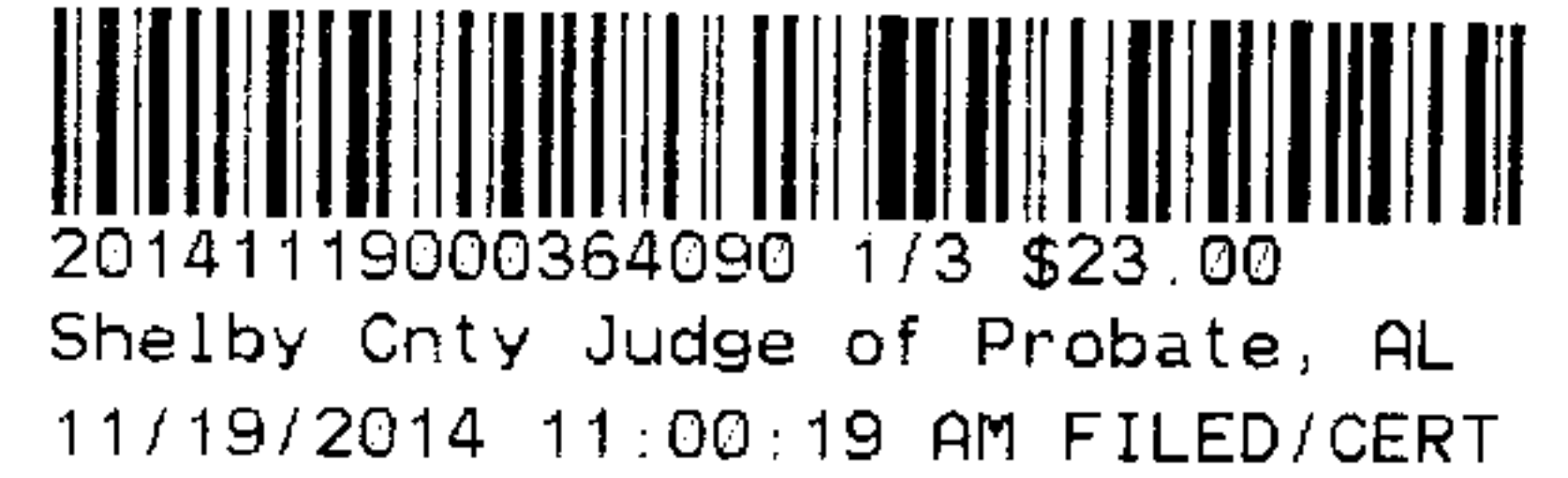

WARRANTY DEED WITH JOINT RIGHT OF SURVIVORSHIP
