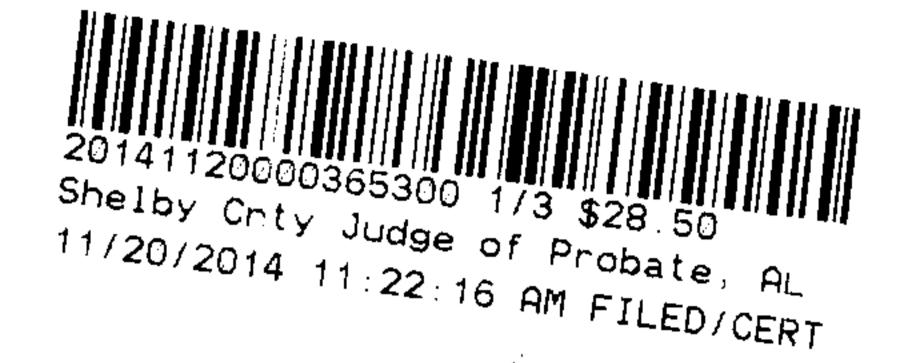

WARRANTY DEED

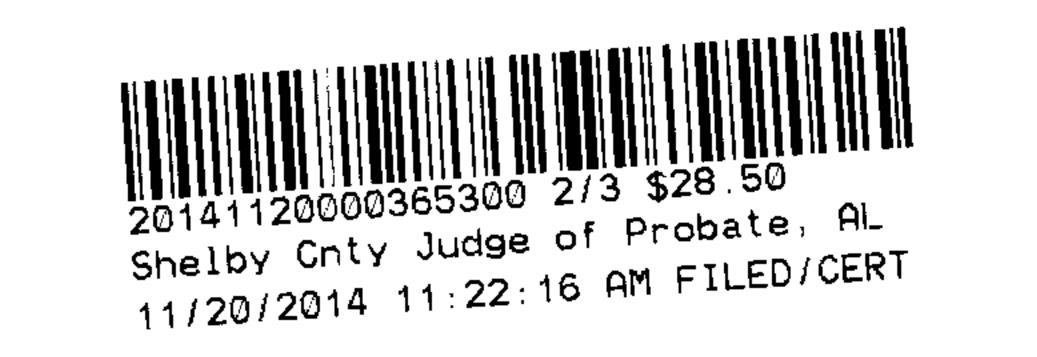
