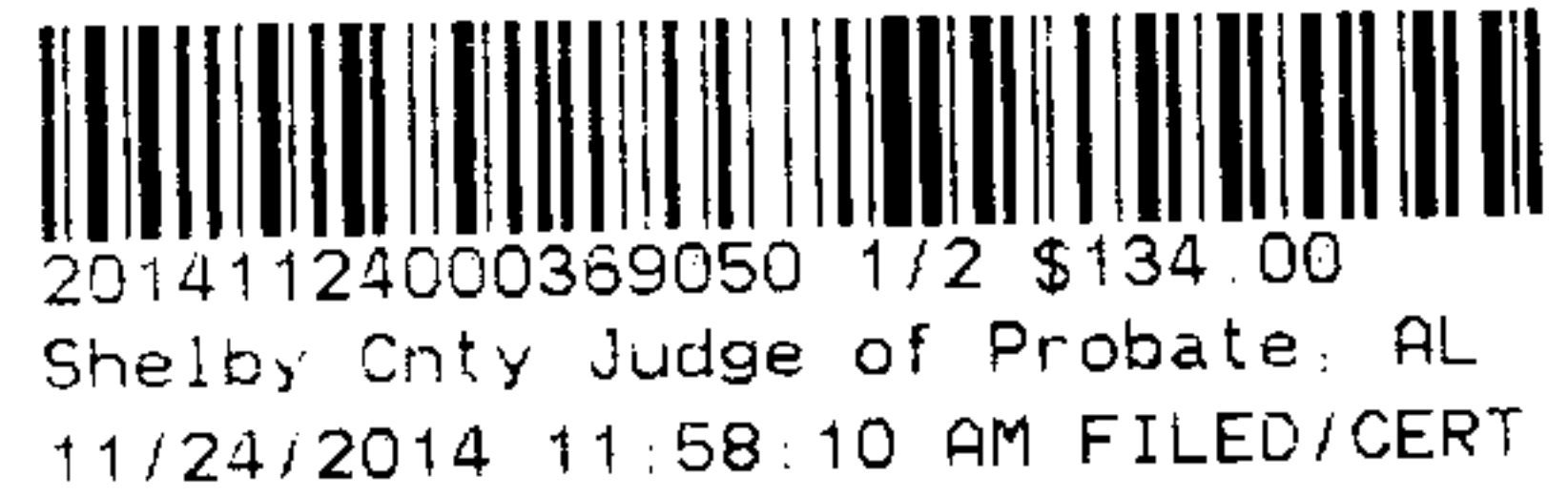


WARRANTY DEED



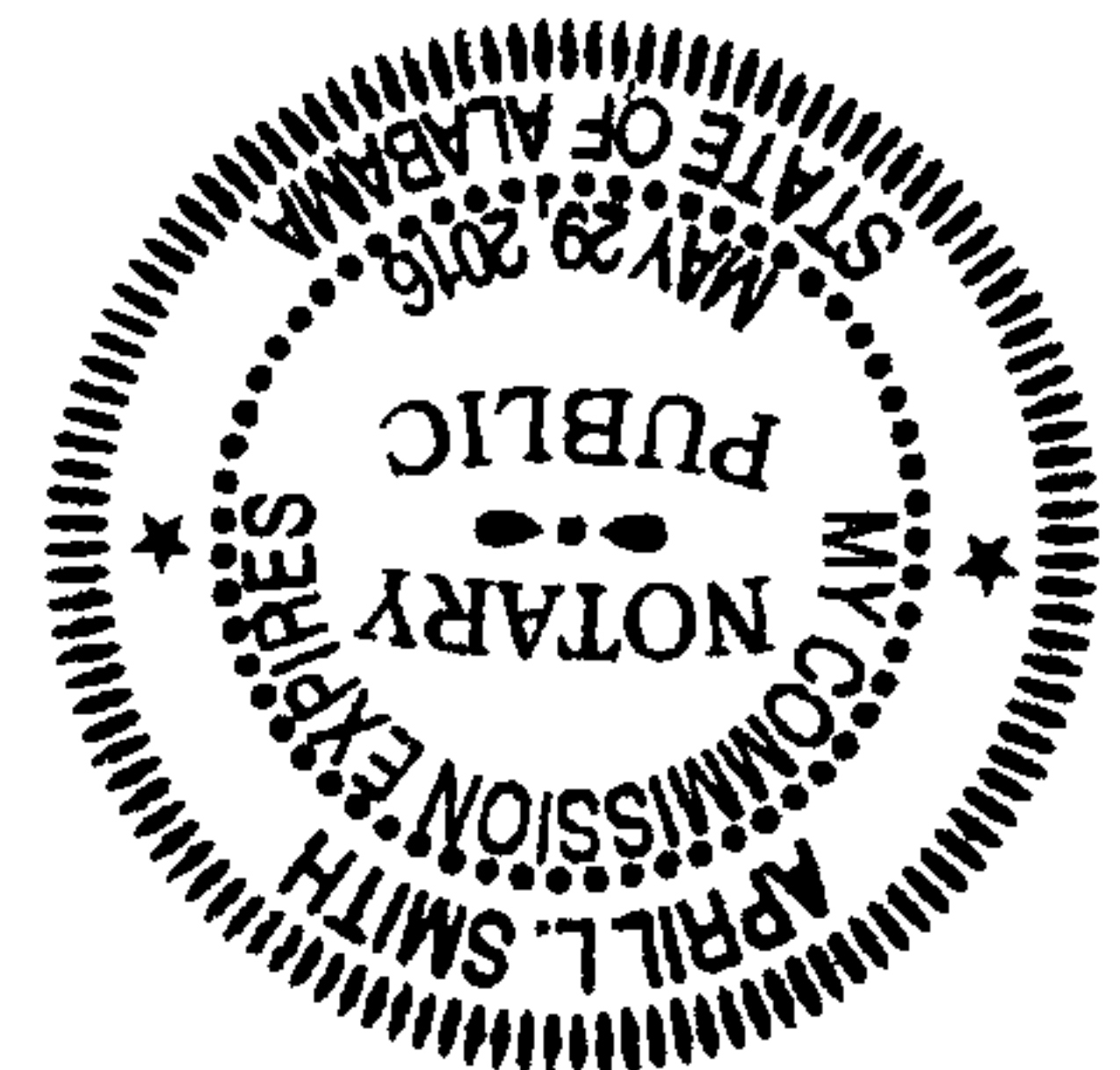

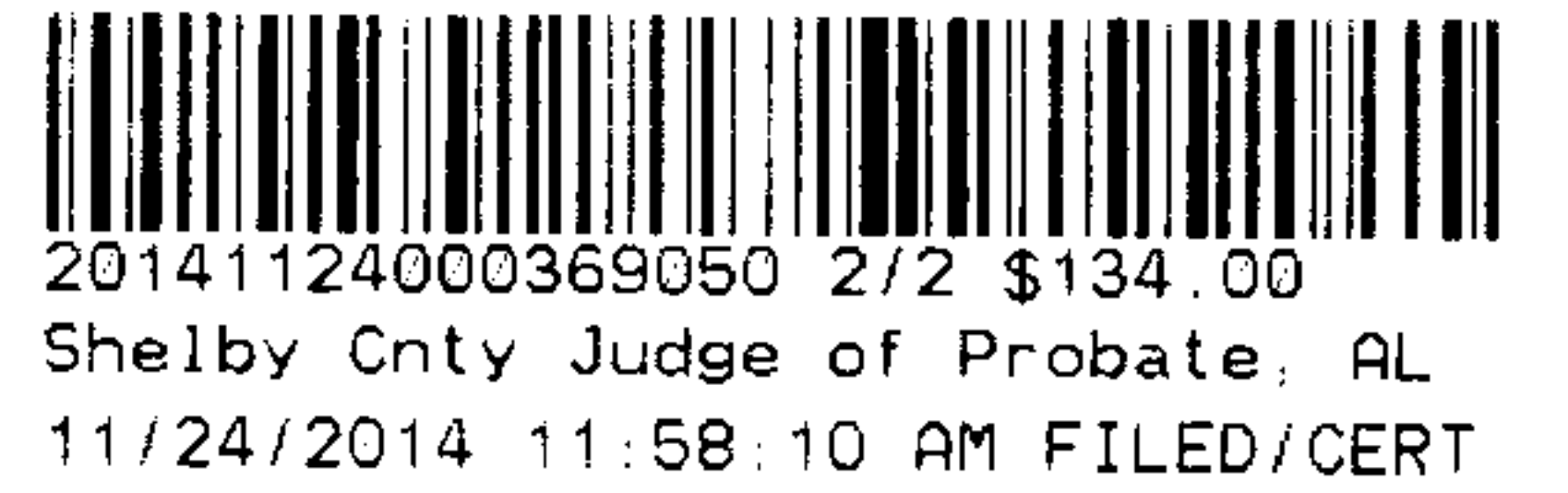
