(hereinafter referred to as "Grantors") do grant, bargain, sell and convey unto

Chris Truss and Lois Truss

(hereinafter referred to as "Grantees") as joint tenants with right of survivorship, the following described real estate situated in **Shelby** County, Alabama to-wit:

Lot 9, according to the Survey of Hollybrook Lakes, as recorded in Map Book 4, page 74, in the Probate Office of Shelby County, Alabama.

Subject to: (1) 2015 ad valorem taxes not yet due and payable;

 (3) all easements, rights-of-way, restrictions, covenants and
 encumbrances of record.

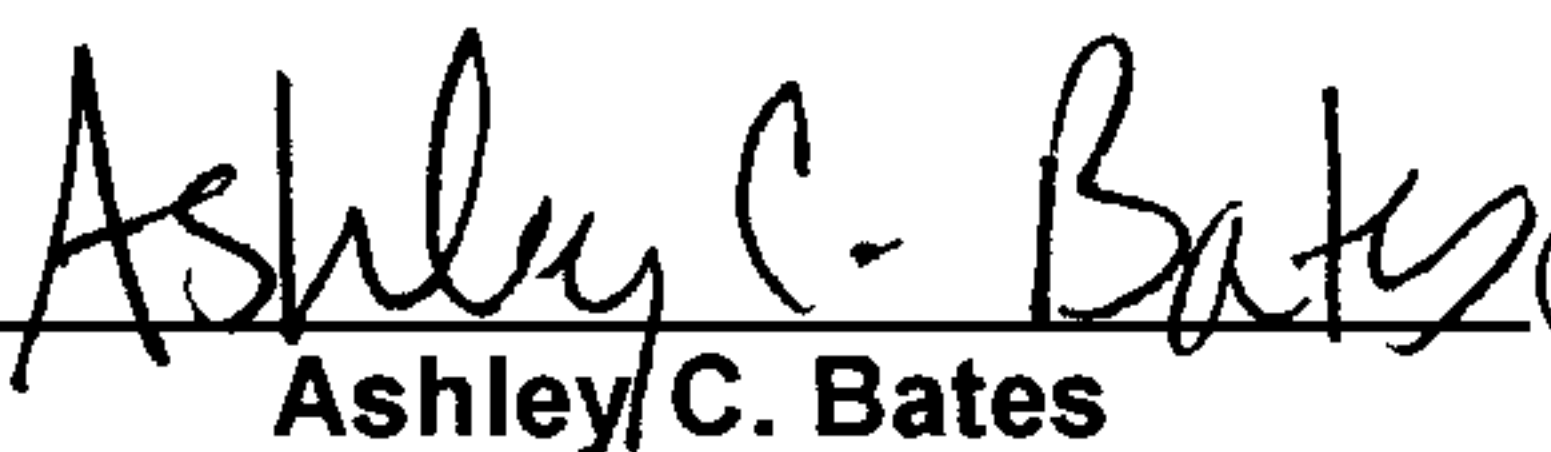

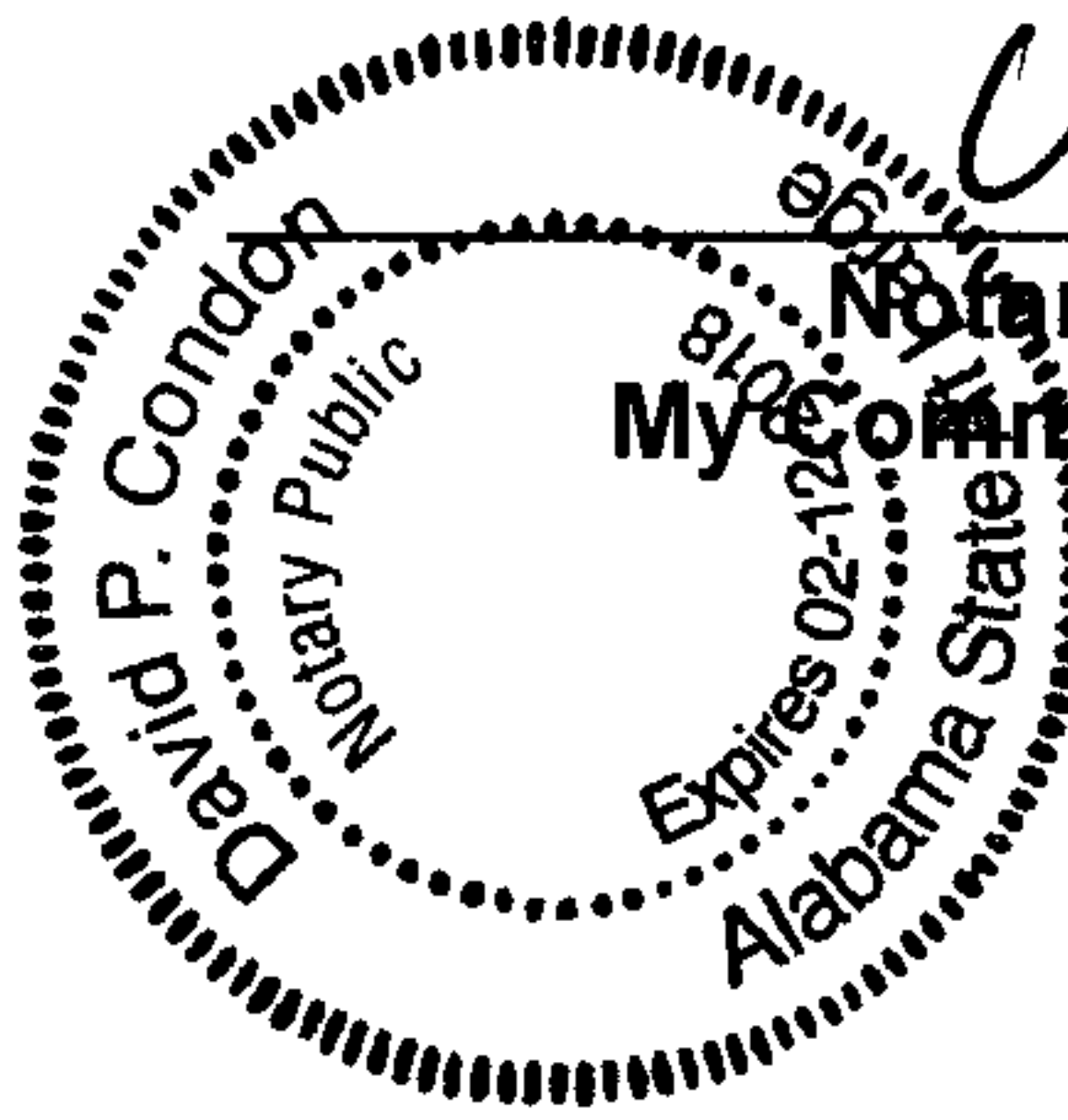
