

**CERTIFICATE OF ARTICLES OF ORGANIZATION

The undersigned being desirous of forming a limited liability corporation under the provisions of Title 10A Section 10A-5-1.01 of the Code of Alabama 1975 Unannotated, **Certificate of formation and all other legal provision of the Code of Alabama** as amended, do hereby make and file the following certificate of Articles of Organization:

1. The name of the Limited Liability Corporation shall be WE-3 LLC.
2. The object for which the Limited Liability Company is formed are:
 - (a) To do a general construction business;
 - (b) To buy, own, sell, lease, subdivide, improve and deal generally in real estate and personal property;
 - (c) To obtain financing for other 3rd parties, either as an broker, consultant, series 7 licensee including offering Syndicated Properties to the general public for ownership under the laws of Mississippi or other states in the United State of America and any other legal means available at law;
 - (d) To own, erect, lease and operate apartment houses and or complexes, retail shopping complexes, office buildings, commercial buildings, condominiums, any other business houses including warehousing, industrial warehousing, industrial plants, food hubs, farming and related businesses thereof including any legal businesses available at law;
 - (e) To do a general contracting business;
 - (f) To do a General Government Contracting business;
 - (g) To act as agent, factor or broker;
 - (h) To subscribe for, buy, sell and own stock, membership positions, notes or bonds of any other corporation or of limited liability company(s) and any other legal entity(s);
 - (i) To borrow money, and for the purpose of carrying on the business aforesaid, to lease, buy, sell, convey, rent and mortgage or pledge both real and personal property as the same shall be necessary incidental to the carrying on of said businesses, and generally to do all things that may be necessary or incidental to the carrying on of said business;
 - (j) To guarantee and be surety for obligations for obligations of others, whether corporate or individual, and whether the obligor is unrelated or related or the common ownership or beneficial ownership;
 - (k) To do any and all others acts which an individual may do under the laws of Alabama and any other state, except acts which this Limited Liability Company may be prohibited from doing under the Laws of Alabama;

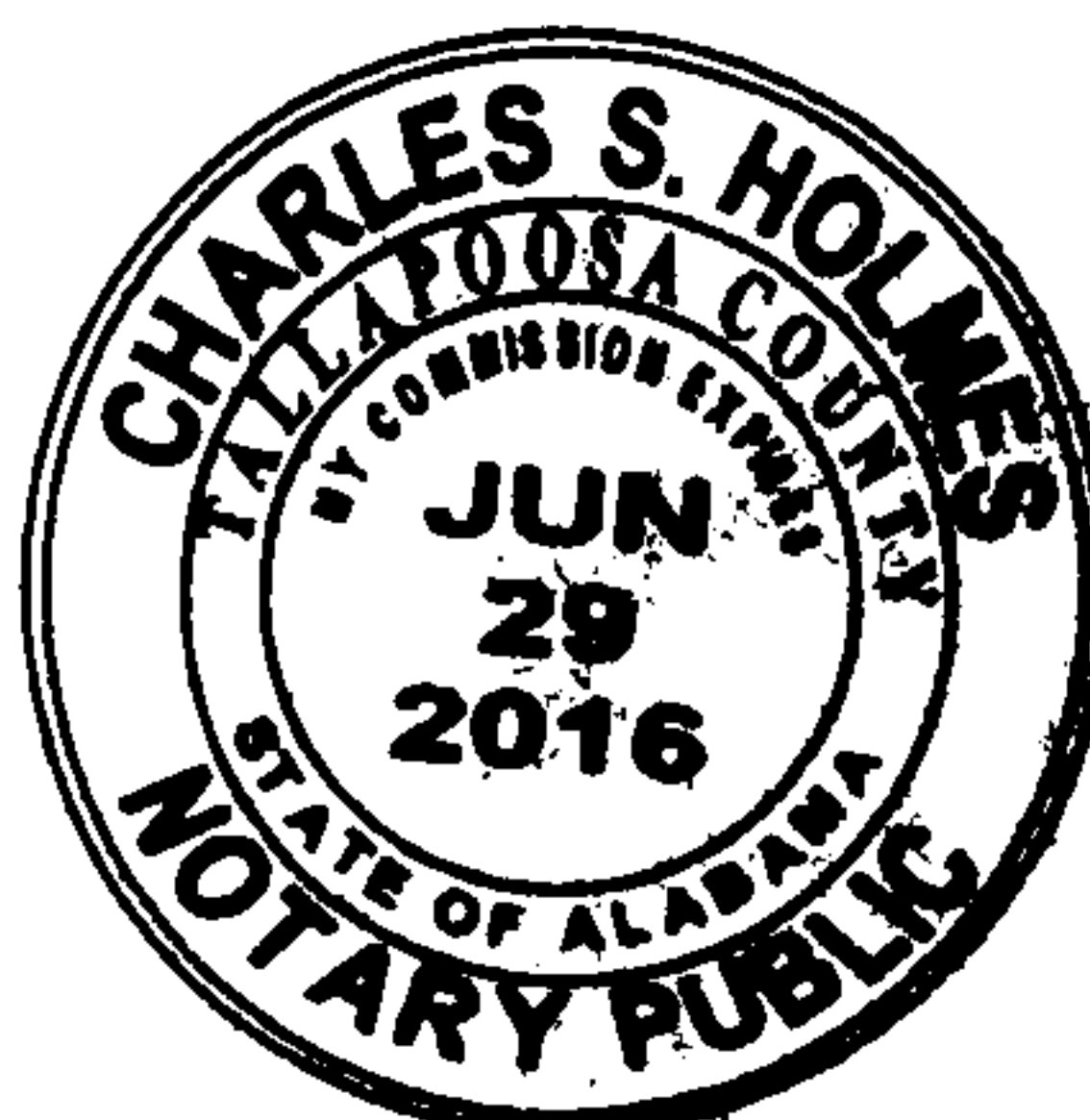
