KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 29th day of September, 1999, Timothy E. Gardner, and wife Rachael L. Gardner, executed that certain mortgage on real property hereinafter described to Countrywide Home Loans, Inc., which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 1999-41284, said mortgage having subsequently been transferred and assigned to Bank of America, N.A., by instrument recorded in Instrument Number 20120622000221030, in the aforesaid Probate Office ("Transferee"); and

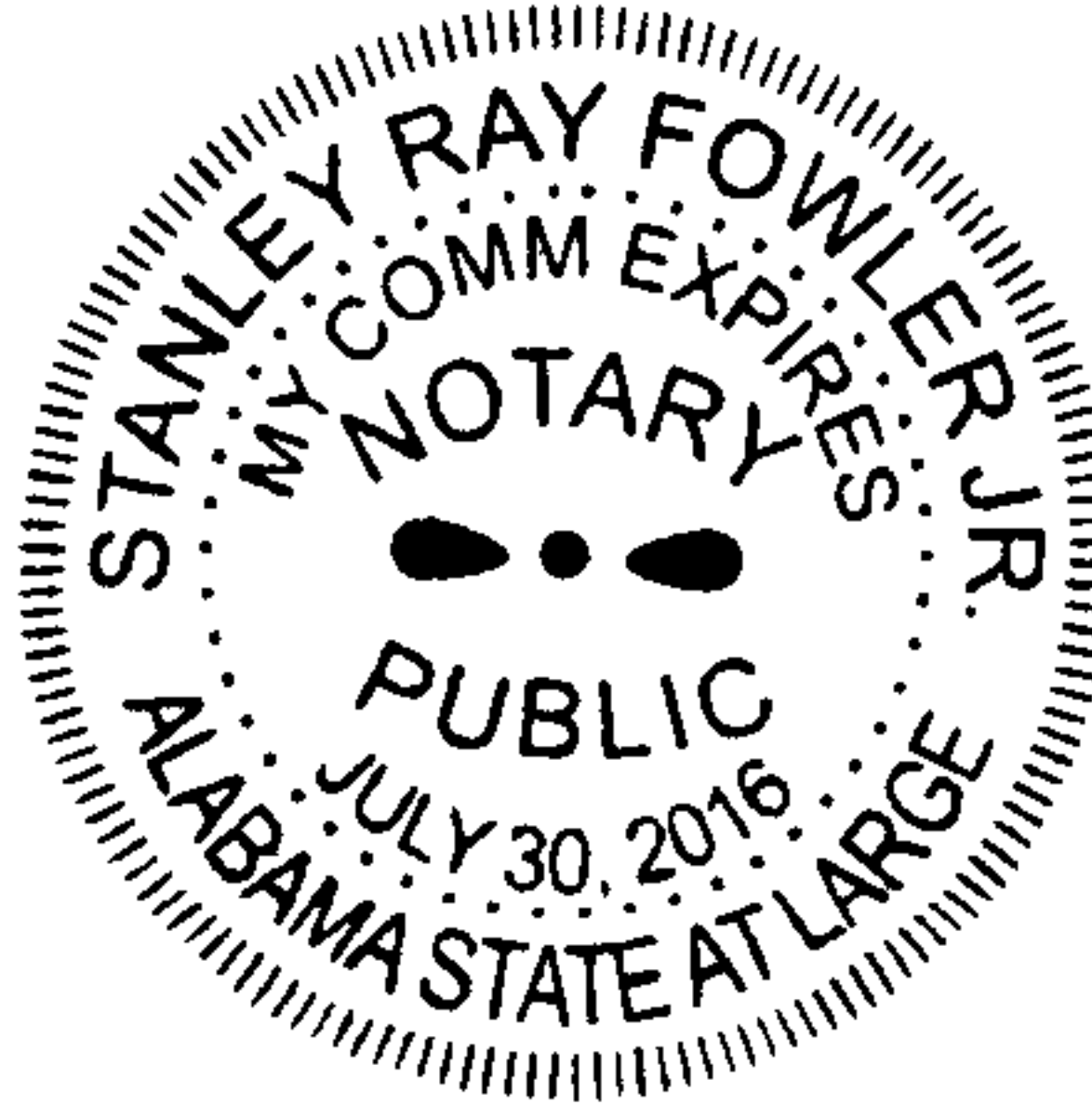
