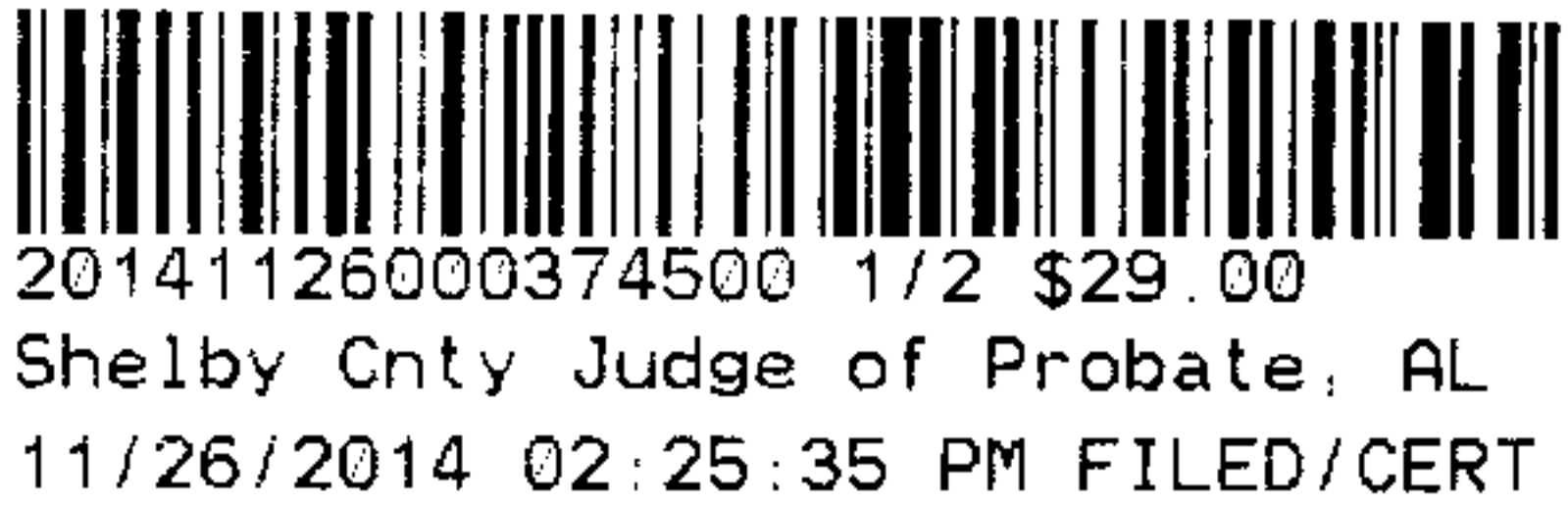

That in consideration of TEN THOUSAND DOLLARS AND OTHER GOOD AND VALUABLE CONSIDERATION to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt whereof is acknowledged, I or we,

ROLAND WEBB AND WIFE, CAROLE WEBB

(herein referred to as Grantor, whether one or more), grant, bargain, sell, and convey unto

ROLAND D. WEBB, CAROLE R. WEBB, AND EMILY E. FRANKLIN, TRUSTEES, OR THEIR SUCCESSORS IN TRUST, UNDER THE WEBB LIVING TRUST, DATED NOVEMBER 13, 2014, AND ANY AMENDMENTS THERETO

(herein referred to as Grantee, whether one or more), the following described real estate, situated in Shelby County, Alabama, to-wit:

Lot 108, according to the Final Plat of Narrows Peak Sector, as recorded in Map Book 31, at Page 125 A & B, in the Office of the Judge of Probate of Shelby County, Alabama.

Together with the nonexclusive easement to use the Common Areas as more particularly described in The Narrows Residential Declaration of Covenants, Conditions and Restrictions recorded as Instrument No. 2000-09755 in the Probate Office of Shelby County, Alabama (which, together with all amendments thereto, is hereinafter collectively referred to as the "Declaration").

Subject to taxes, restrictions, rights-of-way, exceptions, conditions, covenants and easements of record.

ROLAND WEBB and ROLAND D. WEBB are one and the same person. CAROLE WEBB and CAROLE R. WEBB are one and the same person.

EMILY W. FRANKLIN is only a Trustee of the trust. She has no equitable interest in the property nor does she reside on the property.

TO HAVE AND TO HOLD to the said grantee, his, her or their successors and assigns forever.

THE GRANTOR herein grants full power and authority by this deed to the Trustee(s), and either of them, and all successor trustee(s) to protect, conserve, sell, lease, pledge, mortgage, borrow against, encumber, convey, transfer or otherwise manage and dispose of all or any portion of the property herein described, or any interest therein, without the consent or approval of any other party and without further proof of such authority; no person or entity paying money to or delivering property to any Trustee or successor trustee shall be required to see to its application; and all persons or entities relying in good faith on this deed and the powers contained herein regarding the Trustee(s) (or successor trustee(s)) and their powers over the property herein conveyed shall be held harmless from any resulting loss or liability from such good faith reliance.

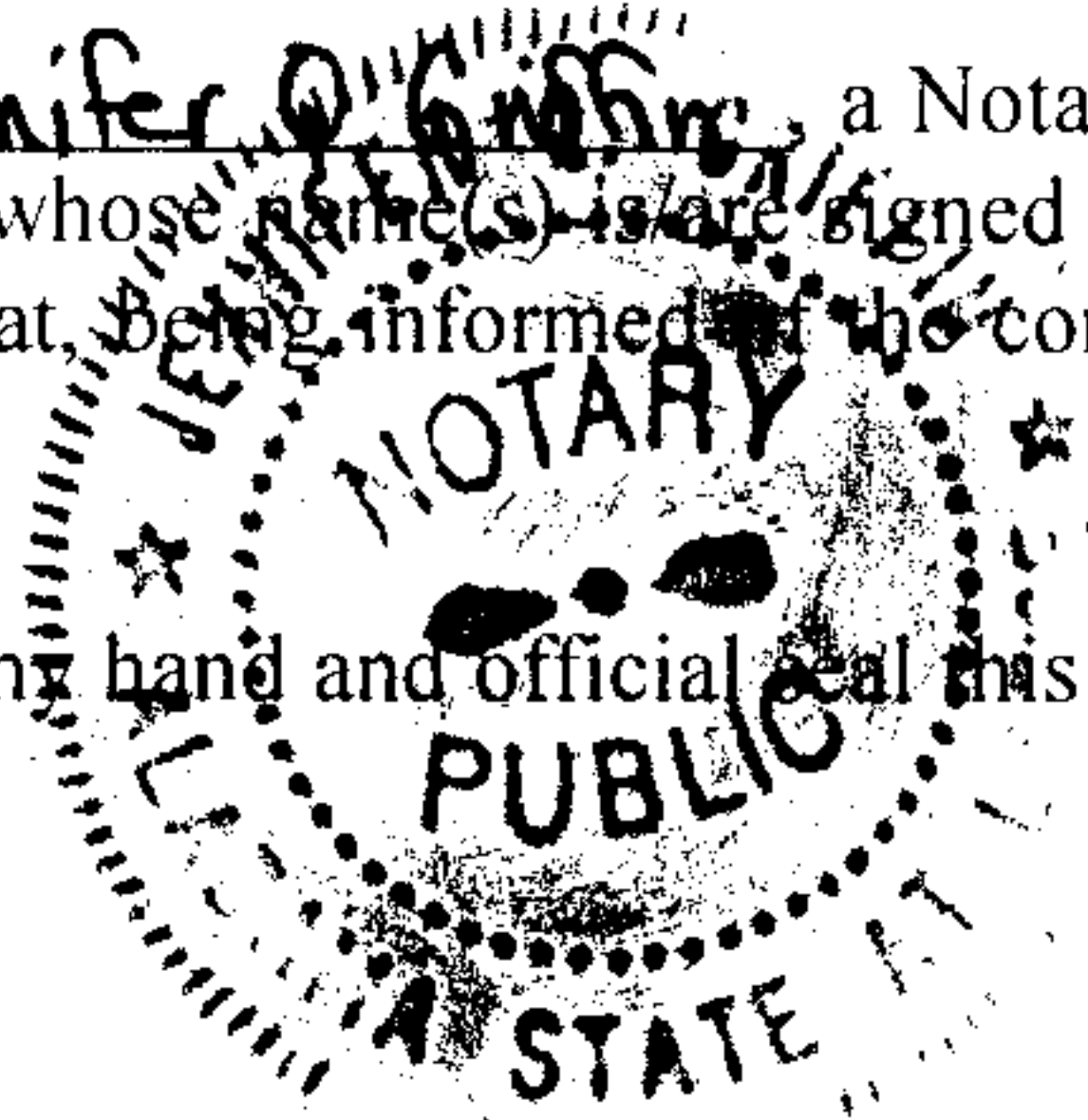
