

CERTIFICATE OF FORMATION

Fowl Play Crosshaven, LLC


Pursuant to the Alabama Limited Liability Company Law as set forth in Chapter 1 and Chapter 5 of the Alabama Business and Nonprofit Entity Code, the undersigned hereby adopts the following Certificate of Formation:

NAME

The name of the limited liability company is Fowl Play Crosshaven, LLC (the "Company").

TYPE

The Company is a limited liability company.



DURATION

The Company shall have perpetual duration unless it is dissolved and its affairs wound up in accordance with the Alabama Business and Nonprofit Entity Code or the Operating Agreement of the Company.

PURPOSES

The purposes for which the Company is formed are:

To acquire real estate or lease property, to engage in construction of improvements on property owned or leased by the Company, for the purpose of actively operating and managing rental property, including, but not limited to business operations, administration, accounting, management and leasing of said real estate owned or leased by the Company as well ownership of other companies engaged in similar operations;

To render to others, and to engage in the business of rendering to others, consulting, advisory, administrative, accounting, bookkeeping, management and other services of every nature, kind and character, which it may legally render;

To act as agent, representative, or receiver of any person, firm, corporation, or governmental entity or instrumentality in respect to any lawful undertaking or transaction;

To purchase, take, receive, lease or otherwise acquire, own, hold, improve, use and otherwise deal in or with, real or personal property, or any interest therein, wherever situated, and to sell, convey, mortgage, pledge, lease, exchange, transfer and otherwise dispose of real or personal property, or any interest therein;

To purchase, take, receive, subscribe for, or otherwise acquire, own, hold, vote, use, employ, sell, mortgage, lend, pledge, or otherwise dispose of, and otherwise use and deal in and with, shares or other interests in, or obligations of, corporations, associations, partnerships, individuals, or direct or indirect obligations of governmental entities or of any instrumentality thereof;

To lend money, invest and reinvest its funds and take and hold real and personal property as security for the payment of funds so loaned or invested; and

To engage in any other lawful act or activity for which limited liability companies may be organized pursuant to the Alabama Limited Liability Company Law.




