KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of Ten and No/100 Dollars (\$10.00) in hand paid to Sherman Industries LLC, a Delaware limited liability company, successor in interest to Sherman Industries, Inc., an Alabama corporation and the successor by merger to Hill Concrete & Supply Company, Inc. 
