GENERAL WARRANTY DEED
With right of survivorship

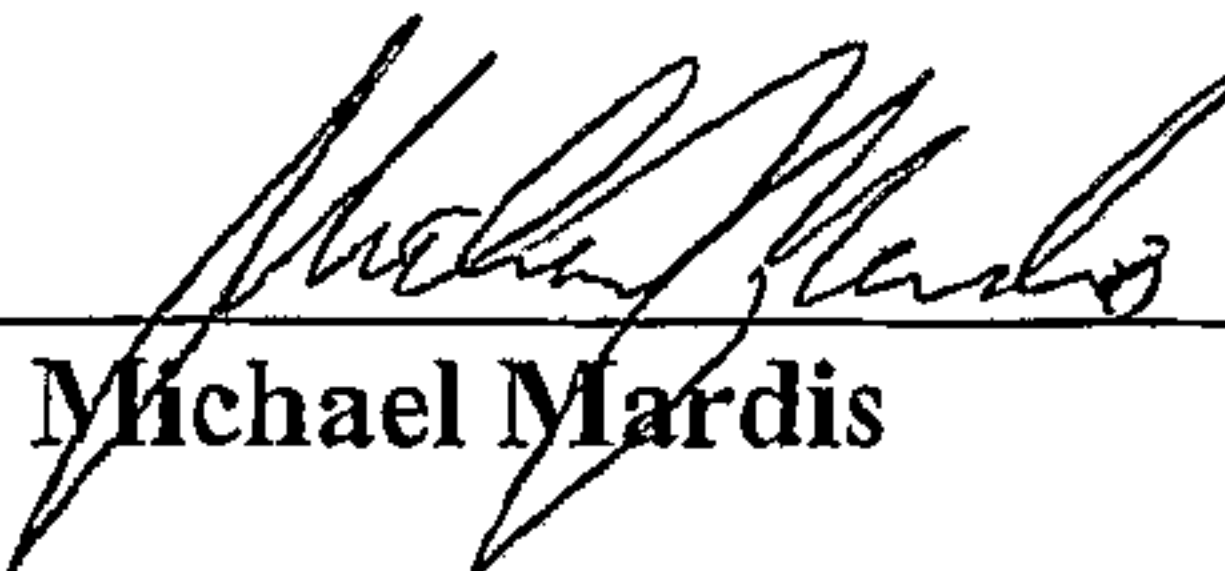
Subject to easements, rights of way, set back lines, restrictions, covenants, mineral and mining rights and current taxes due.

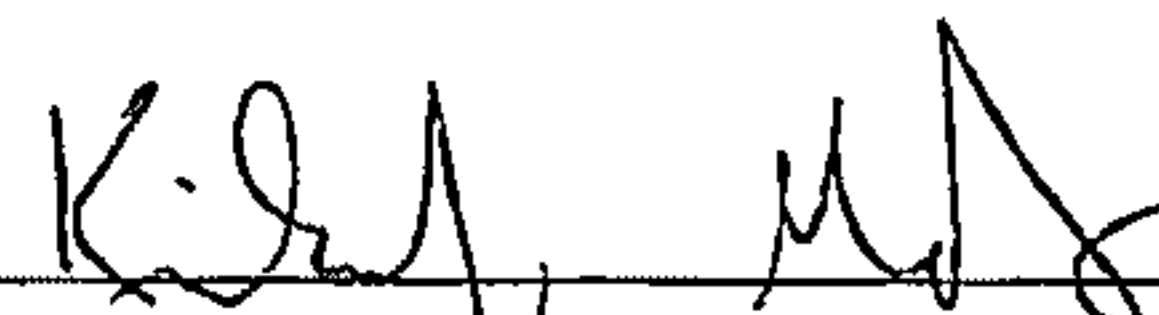
310,000.00 of the above consideration was secured by and through the purchase money mortgage closed herewith.

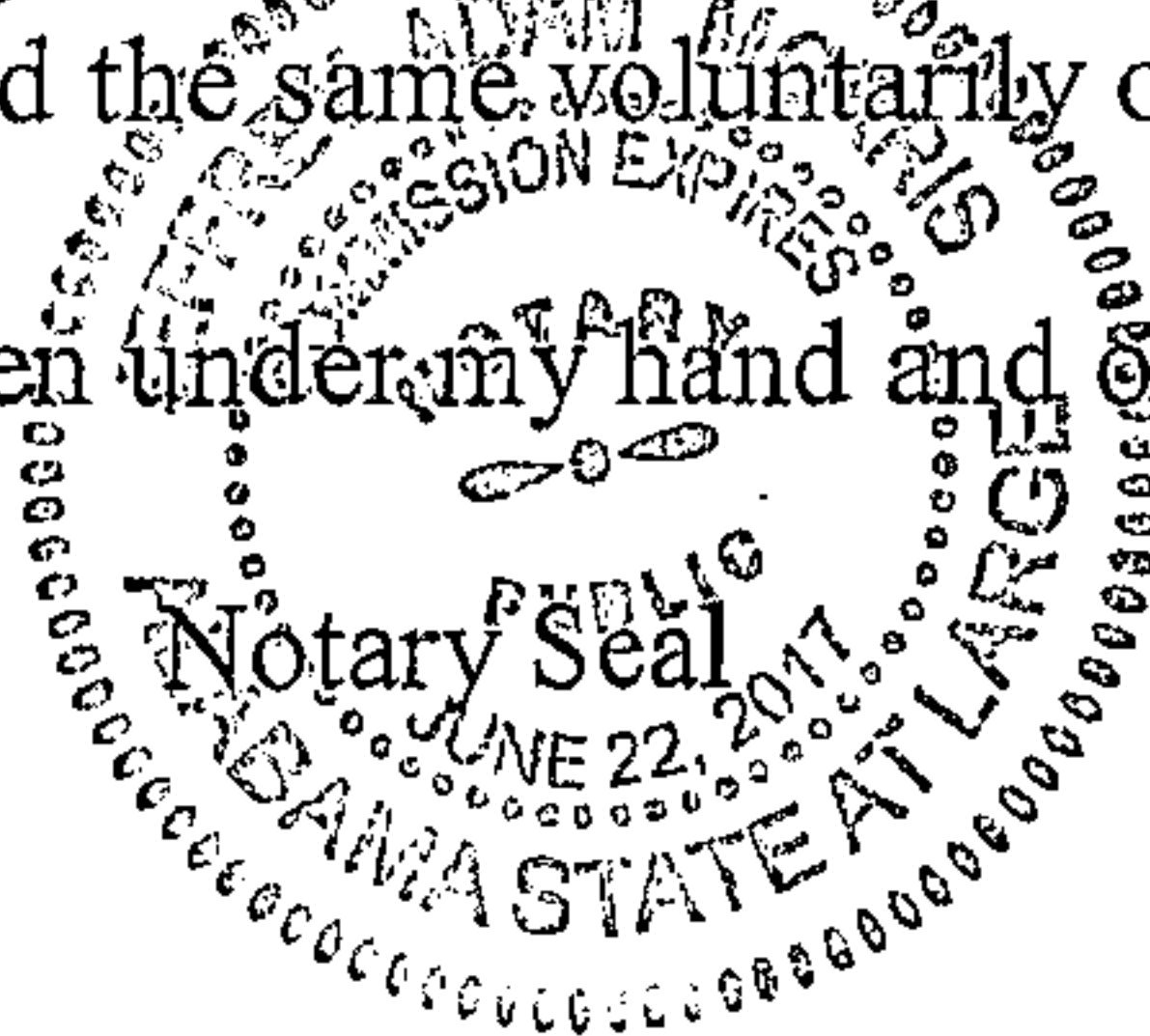

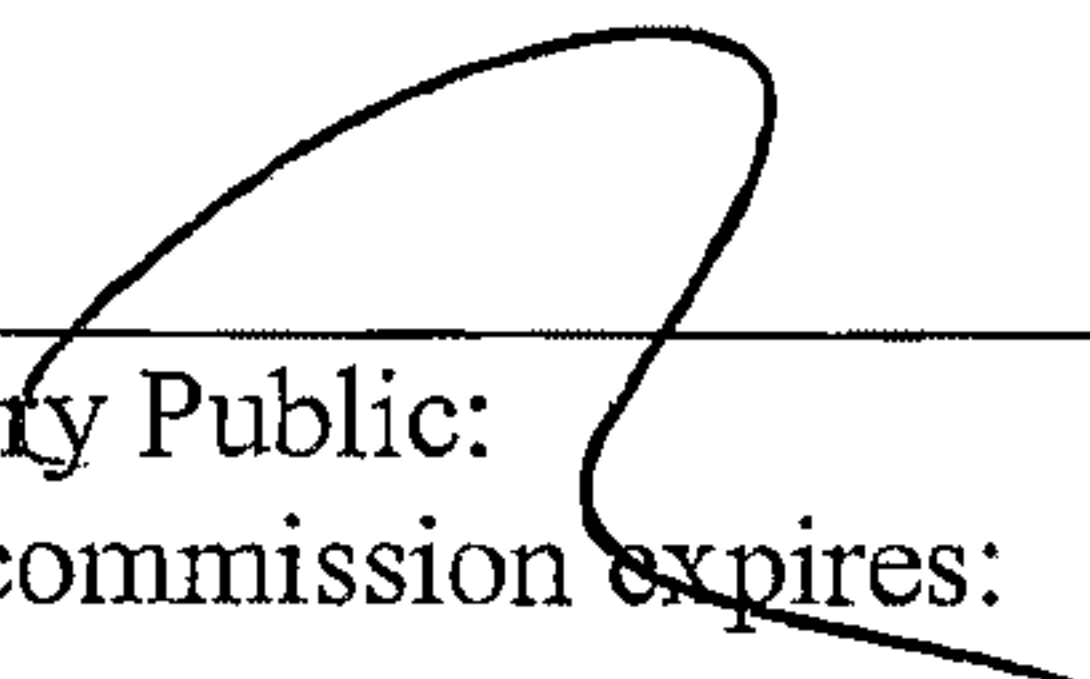

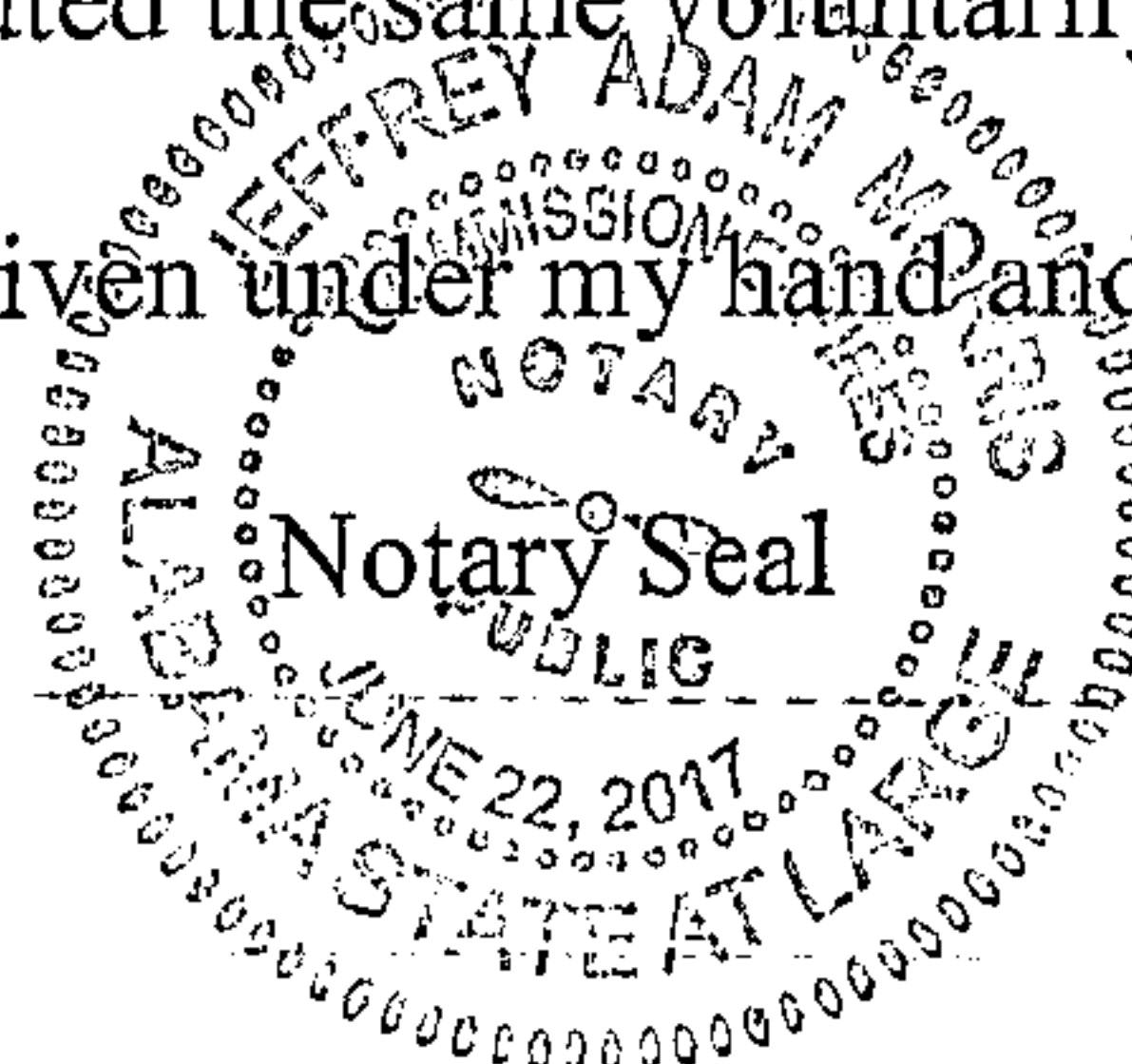
