Subject to Easements, Restrictions and rights of way of record.


Subject to Mineral and Mining rights of record.



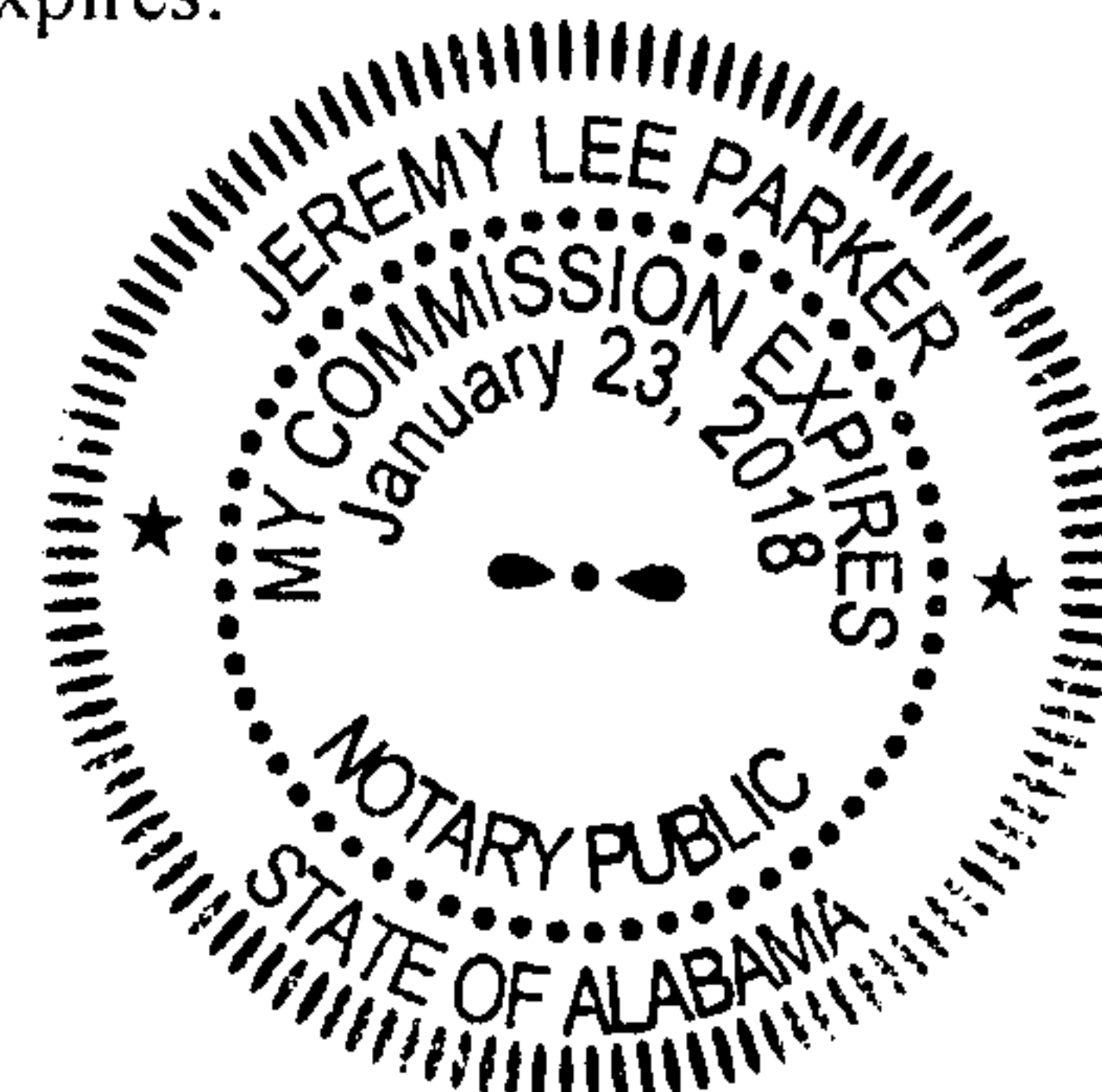

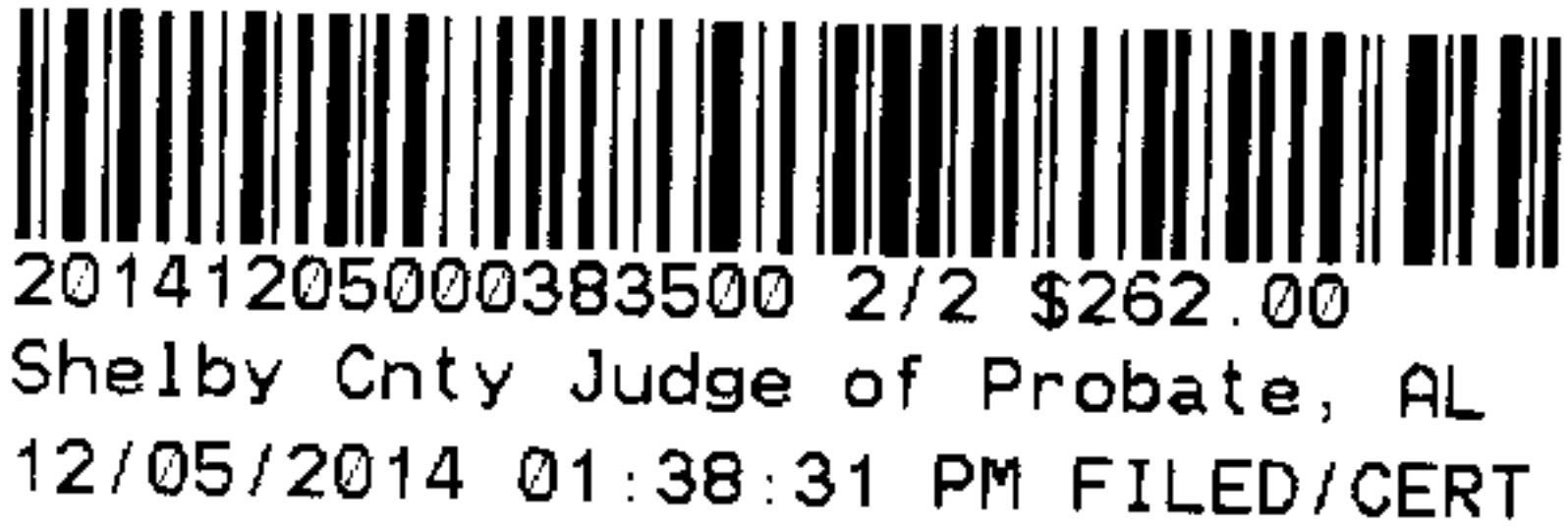
