

## Warranty Deed

**Know all Men by these Presents:** That, in consideration of Two Hundred Three Thousand Nine Hundred and No/100ths Dollars (\$203,900.00) and other good and valuable consideration to them in hand paid by the Grantees herein, the receipt of which is hereby acknowledged, **DANIEL D. BETHERS AND DEBORAH GILES BETHERS, Husband and Wife** (herein referred to as "Grantors") do by these presents grant, bargain, sell and convey unto **GREGORY L. NEWTON AND MARSHA D. NEWTON** (herein referred to as "Grantees") for and during their joint lives and, upon the death of either of them, then to the survivor, in fee simple, and to the heirs and assigns of such survivor forever, together with every contingent remainder and right of reversion, the following described real estate situated in Shelby County, Alabama, to-wit:

Lot 21, according to the Survey of Panther Ridge, as recorded in Map Book 31, page 118, in the Probate Office of Shelby County, Alabama.

This conveyance is subject to subdivision restrictions, utility, drainage and sewer easements, and minimum setback lines, if any, applicable to the aforesaid property appearing of record in the Office of the Judge of Probate of Shelby County, Alabama. This conveyance is also subject to any prior reservation, severance or conveyance of minerals or mineral rights, taxes and assessments for the year 2014 and all subsequent years, and the following:

1. **Building Setback line of 25 feet reserved from Victory Trail, as shown per plat.**
2. **Utility easements as shown by recorded plat, including, 5 feet from Victory Trail.**




