### FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on September 1, 2011, to-wit: Gary W. Latimer and Cassie N. Latimer, husband and wife, executed a mortgage to Mortgage Electronic Registration Systems, Inc. solely as nominee for Synovus Mortgage Corp., its successors and assigns, herein called the Mortgagee, which said mortgage was recorded on September 2, 2011, in Instrument No. 20110902000261540, Probate Records of Shelby County, Alabama, which conveyed the property hereinafter described to secure the indebtedness evidenced by a note, payable in installments, therein described; which said mortgage was subsequently assigned to JPMorgan Chase Bank, National Association, by assignment recorded November 13, 2013 in Instrument No. 20131113000446240, Probate Records of Shelby County, Alabama; and
