

## DOMESTIC BUSINESS CORPORATION ARTICLES OF DISSOLUTION

PURPOSE: In order to dissolve a Business Corporation (formerly known as For-Profit Corporation) under Section 10A-1-9.11 and 10A-2-14.03 of the Code of Alabama 1975 these Articles of Dissolution and the appropriate filing fees must be filed with the Office of the Judge of Probate in the county where the corporation's Certificate of Formation was recorded. The information required in this form is required by Title 10A.

INSTRUCTIONS: Mail one (1) signed original and two (2) copies of this completed form and the appropriate filing fees to the Office of the Judge of Probate in the county where the

corporation's Certificate of Formation was recorded. Contact the Judge of Probate's Office to determine the county filing fees. Make a separate check or money order payable to the Secretary of State for the state filing fee of \$100.00 and the Judge of Probate's Office will transmit the fees along with a certified copy of the Articles of Dissolution to the Office of the Secretary of State within 10 days after the filing is recorded. Once the Secretary of State's Office has indexed the filing, the information will appear at <a href="https://www.sos.alabama.gov">www.sos.alabama.gov</a> under the Government Records tab and the Business Entity Records link – you may search by entity name or number. You may pay the Secretary of State fees by credit card if the county you are filing in will accept that method of payment (see attached). Your dissolution will not be indexed if the credit card does not authorize and will be removed from the index if the check is dishonored.

The dissolution was approved by written consent of all shareholders under Section 10A-2-14.02(f) and a copy of the written consent or consents signed by all the shareholders of the corporation is attached to and made part of this Articles of Dissolution document.
The Articles of Dissolution are effective on the date the document is recorded in the Office of the Judge of Probate. The corporation may file a Revocation of Dissolution with the Office of the Judge of Probate within 120 days of the effective date. After the 120 days for Revocation lapse, a corporation cannot revoke or reinstate it must be filed as a new Certificate of Formation.

Pursuant to Section 10A-1-9.11 and 10A-2-14.03 of the Code of Alabama 1975, the undersigned

corporation submits the following notice of intent to dissolve the corporation:

1. The name of the corporation is: MHR Services, Inc.

2. On October 13, 2014, the shareholders of the corporation unanimously adopted a

resolution to begin dissolution of the corporation on October 13, 2014. The resolution

further sets forth the following:

A. That at the earliest practicable date, the following will be accomplished:

(1) Complete liquidation of MHR Services, Inc.,

(2) Payment of all corporate debts, and

(3) Distribution of any remaining cash, securities, and cash realized from the

sale of securities or corporate assets to the stockholders.

B. That the directors and officers of MHR Services, Inc. are authorized and directed

to immediately initiate the liquidation of the corporation so that its assets or the

proceeds therefrom can be distributed to its stockholders prior to October 13,

2014.

C. That promptly thereafter, the charter and franchise of MHR Services, Inc. will be

surrendered and the corporation dissolved.

D. That MHR Services, Inc. discontinued transacting all business as of December

31, 2013, except that which is necessary or incidental to liquidation and winding

up affairs.
