CERTIFICATE OF FORMATION

Pursuant to the Alabama Limited Liability Company Act, the undersigned hereby adopts the following articles of this Certificate of Formation:

**ARTICLE I
NAME AND PRINCIPAL OFFICE**

The name of the limited liability company is TWISTED SCISSORS, LLC. The company's principal office address is 710 Inverness Corners, Suite 2, Birmingham, AL 35242.

**ARTICLE II
DURATION**

The period of duration of the Company shall be perpetual; provided, that the limited liability company shall cease to exist upon dissolution of the limited liability company in accordance with Section 37 of the Alabama Limited Liability Company Act.

**ARTICLE III
PURPOSE**

The purpose for which the limited liability company is organized is the transaction of any and all lawful business for which a limited liability company may be organized under the Alabama Limited Liability Act, including, without limitation, providing general styling, grooming, and spa services; and to do everything necessary, advisable, or convenient, for the accomplishment of the foregoing purposes.

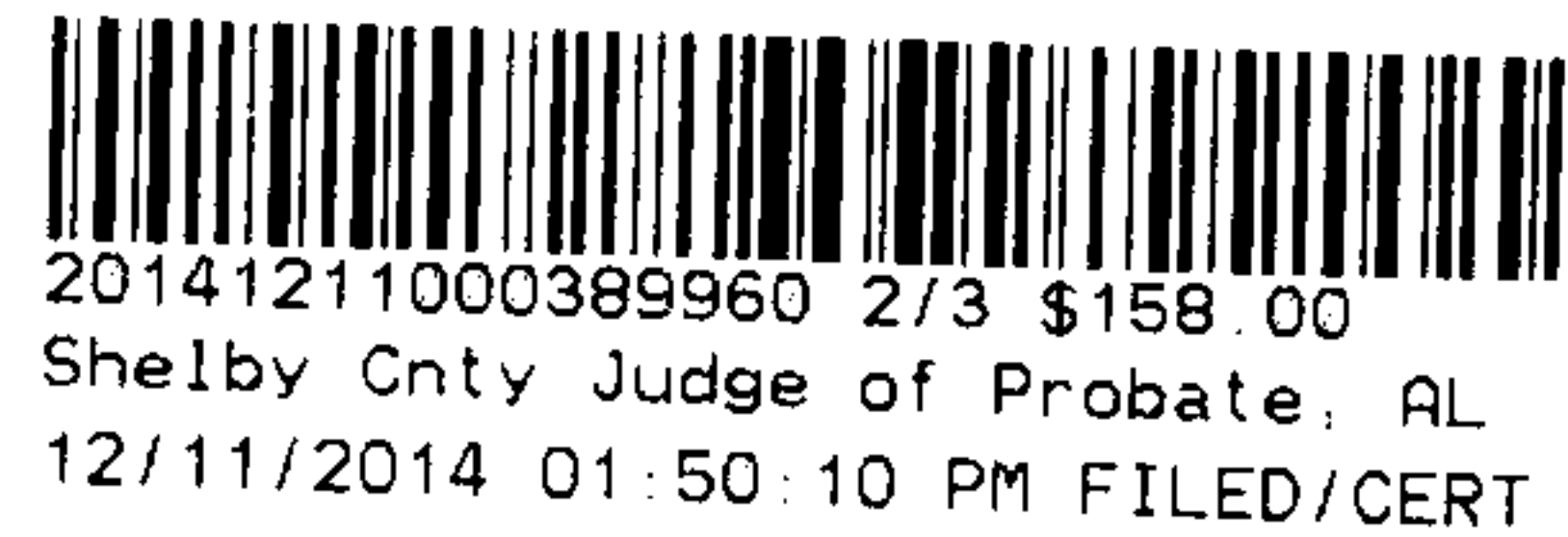
**ARTICLE V
