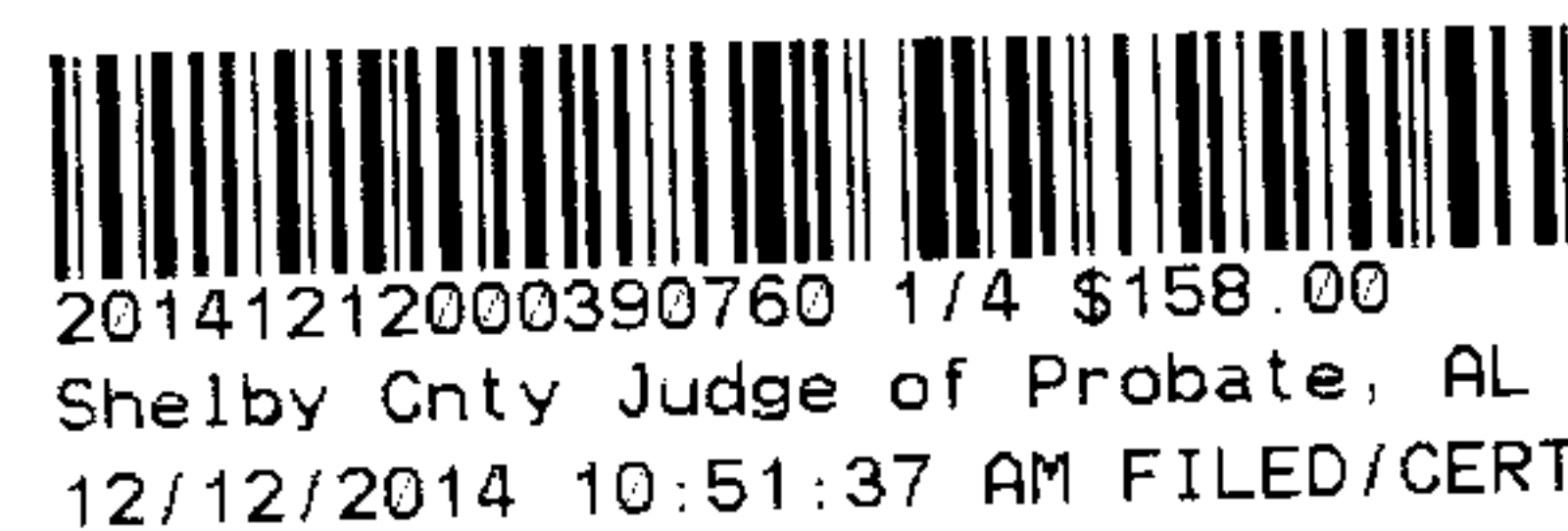


**CERTIFICATE OF FORMATION
OF
WAVEFORM, LLC**



TO THE HONORABLE JUDGE OF PROBATE,
SHELBY COUNTY, ALABAMA:

Pursuant to the provisions of the Alabama Limited Liability Company Law ("Law"), the undersigned hereby adopts the following Certificate of Formation:

**Article I
Name**

The name of the entity being formed is Waveform, LLC, an Alabama limited liability company ("Company").

**Article II
Purpose**

The purpose for which the Company is formed is the transaction of any and all lawful business for which a limited liability company may be organized under the Law.

**Article III
Duration**

The Company's duration will be perpetual; provided, however, that the Company will cease to exist upon the Company's dissolution in accordance with Section 10A-5-7.01 of the Law.


**Article IV
Initial Registered Agent and Registered Office**

The street address and mailing address of the Company's initial registered office are 413 Dovecote Circle, Birmingham, Alabama 35244. The name of its initial registered agent at such address is Scott Schram.

**Article V
Organizer**

The name and address of the Company's organizer are Frederic L. Smith, Jr. and 1819 Fifth Avenue North, Birmingham, Alabama 35203.

Members; Membership

The Company's members will have the right to admit additional members (including substitute members) in accordance with the Company's operating agreement, as may be in effect from time to time (the "Operating Agreement"); provided, however, that if there is only one remaining member of the Company, and such member assigns the member's entire membership interest (including financial and other rights), the assignee of such membership interest will automatically be admitted as a substitute member of the Company.

Except as specifically required by any non-waivable provisions of the Law or any provisions of the Operating Agreement, the cessation of a member's membership in the Company will not result in the Company's dissolution. If a member ceases to be a member of the Company (whether such cessation is voluntary or involuntary), and such member was at the time of such cessation of membership the only remaining member of the Company, the holders of all the financial rights in the Company may agree in writing to continue the legal existence and business of the Company and to appoint one or more new members.

Article VII
Operating Agreement

The regulation of the internal affairs of the Company, if not set forth herein, will be governed by the Operating Agreement.
