The Association claims a lien upon property owned by **Bernard & Melissa Badami**, situated in Shelby County, Alabama described as follows:

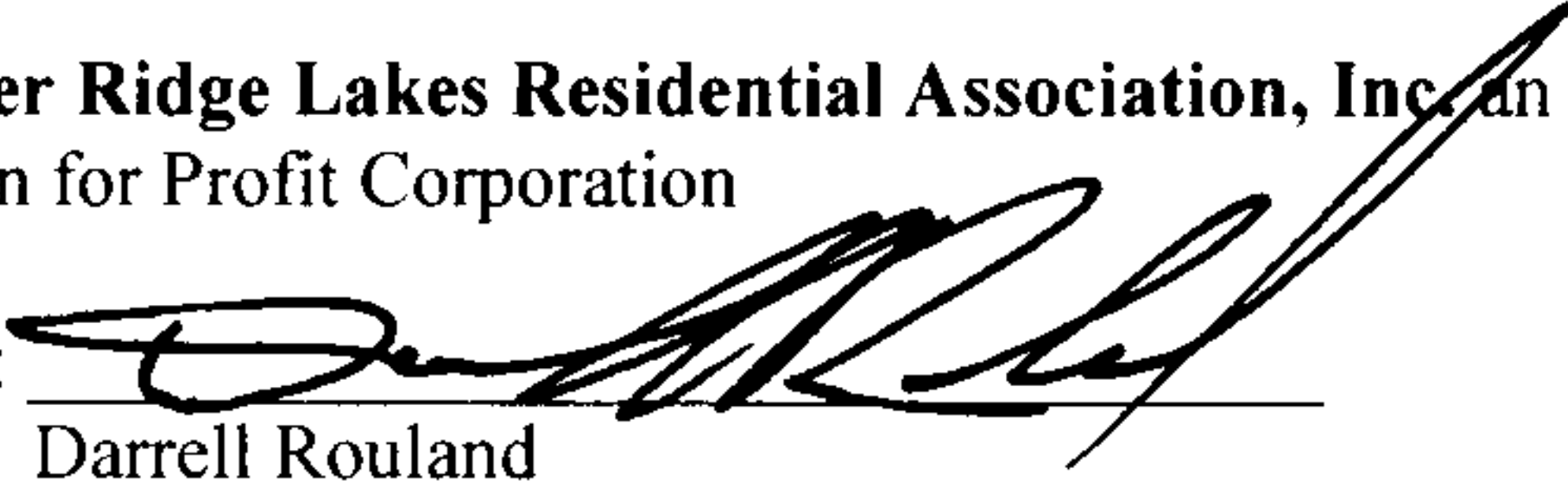

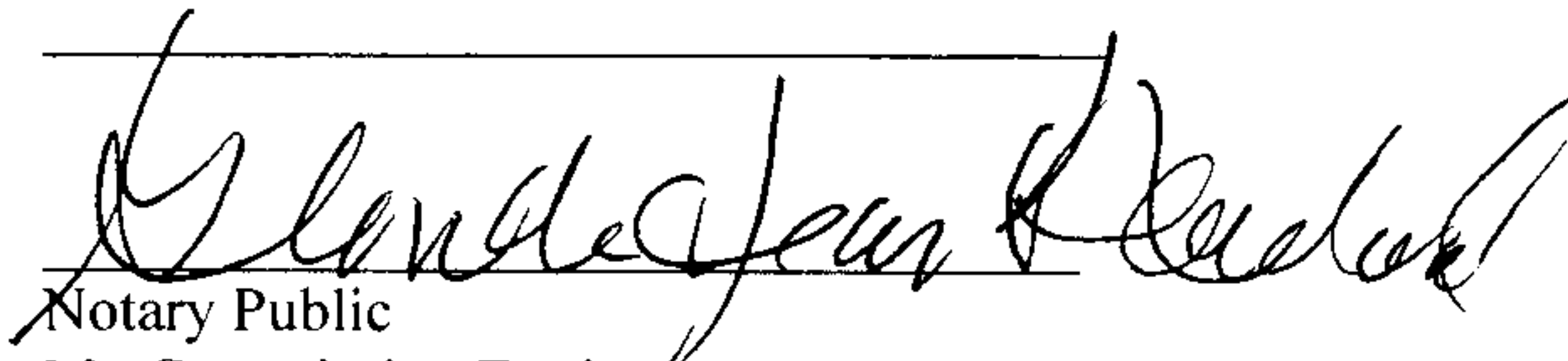
