The Association claims a lien upon property owned by **Julius & Cicely Martin**, situated in Shelby County, Alabama described as follows:

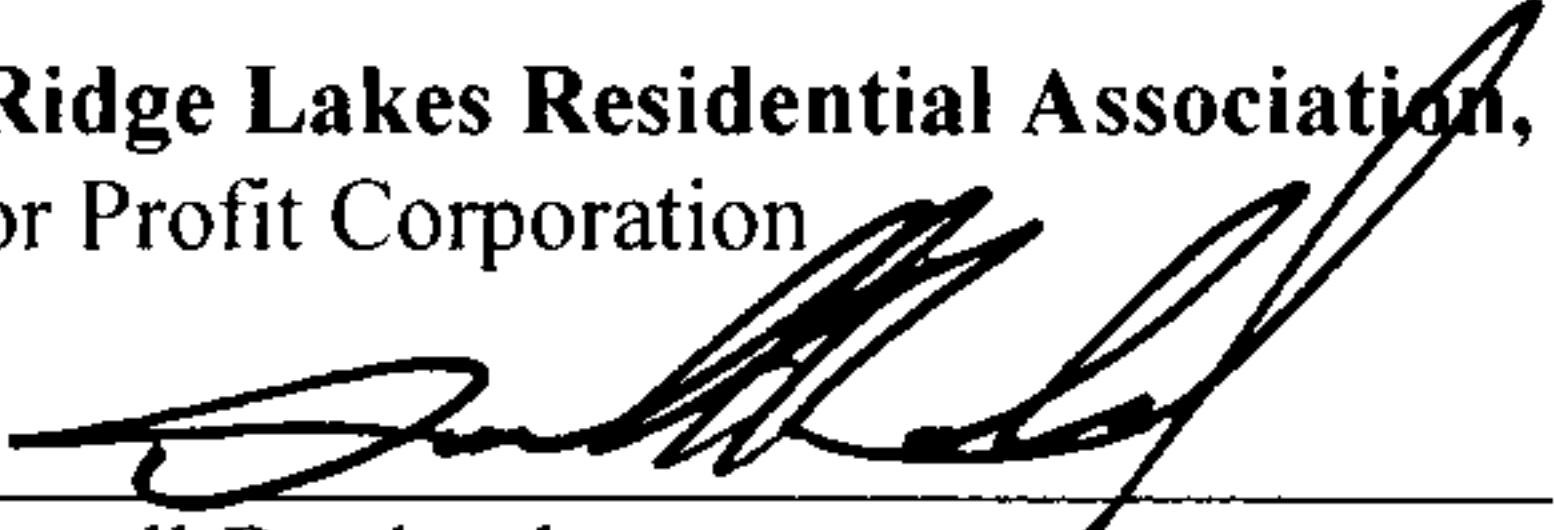

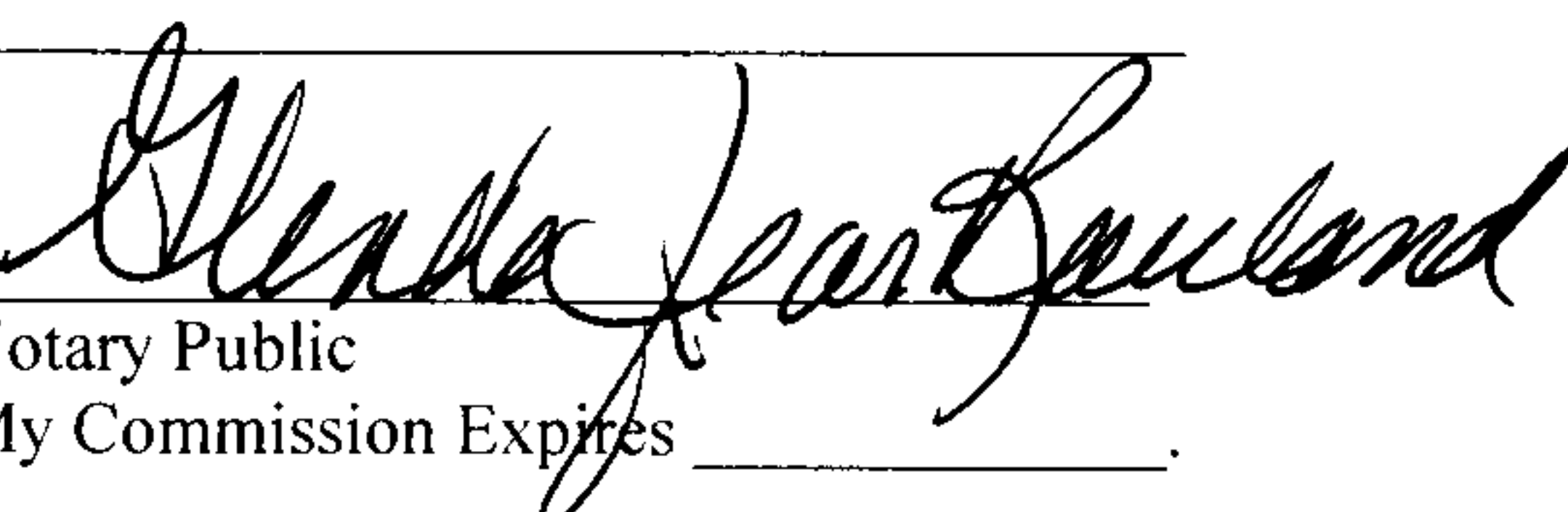
