CERTIFICATE OF FORMATION

Pursuant to the Alabama Limited Liability Company Act, the undersigned hereby adopt the following articles of this Certificate of Formation:

ARTICLE I Name and Principal Office Address

The name of the limited liability company is C & C Masonry of Central Alabama, LLC. The Company's principal office address is 324 Highway 338 Chelsea, AL 35043.

ARTICLE II Duration

The period of duration of the Company shall be perpetual; provided, that the limited liability company shall cease to exist upon dissolution of the limited liability company in accordance with Section 37 of the Alabama Limited Liability Company Act.

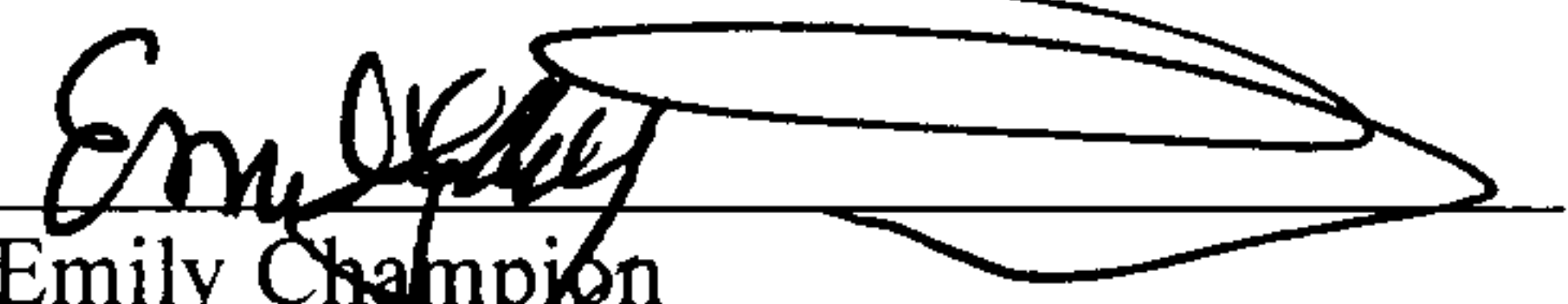
**ARTICLE VIII
