Your dissolution will not be indexed if the credit card does not authorize and will be removed from the index if the check is dishonored.

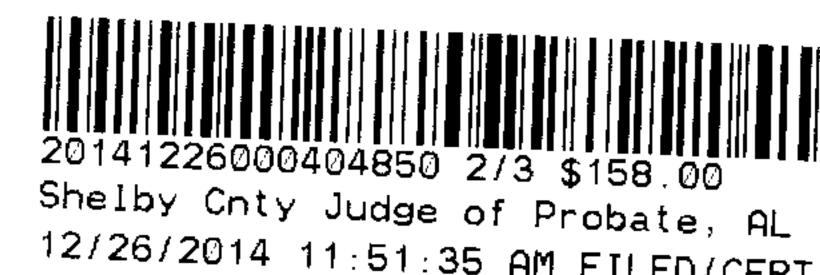

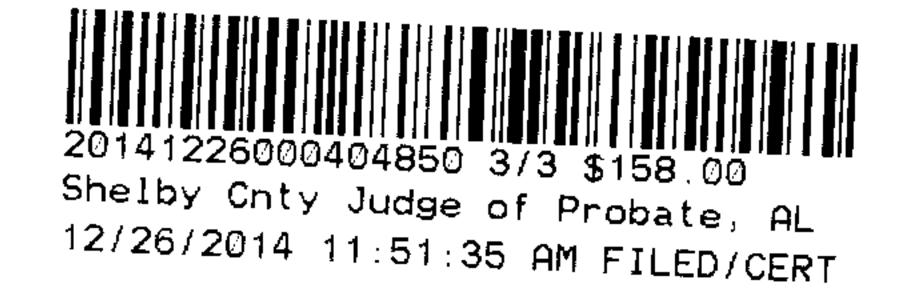
