KNOW ALL MEN BY THESE PRESENTS, that, WHEREAS, on or about June 22, 2012, Casey Lee House, a single man, executed a mortgage conveying the real estate hereinafter described in Shelby County, Alabama, to Michael's Jewelry & Pawn, Inc., as Mortgagee, which said mortgage was recorded on June 29, 2012, at 04:04:51 PM, in Instrument #20120629000230670, and subsequently assigned to Palmer and Son, Inc., by assignment dated November 17, 2014, filed for record on November 19, 2014, at 03:47:33 PM, and recorded in Instrument #20141119000364810, in the Office of the Judge of Probate of Shelby County, Alabama (hereinafter referred to as "said mortgage" or words to that effect), which said mortgage and the indebtedness secured thereby is and was as of the date upon which this foreclosure proceeding was instituted, and is and was as of the date upon which this foreclosure deed was executed, the sole property of said Mortgagee; and

WHEREAS, in and by said mortgage said Mortgagee was authorized and empowered in case of default in the payment of the indebtedness thereby secured according to the terms thereof, to sell said real estate in front of the Court-house door in the City of Columbiana, Shelby County, Alabama, after giving twenty-one days notice of the time, place, and terms, of said sale, by publication once a week for three consecutive weeks prior to said sale in some newspaper published in Shelby County, Alabama, such sale to be at public outcry for cash, to the highest bidder, and said mortgage provided that in case of sale under the power and authority contained in the same the Mortgagee or any person conducting said sale for the Mortgagee might bid at the same and purchase said property if the highest bidder therefor; and







