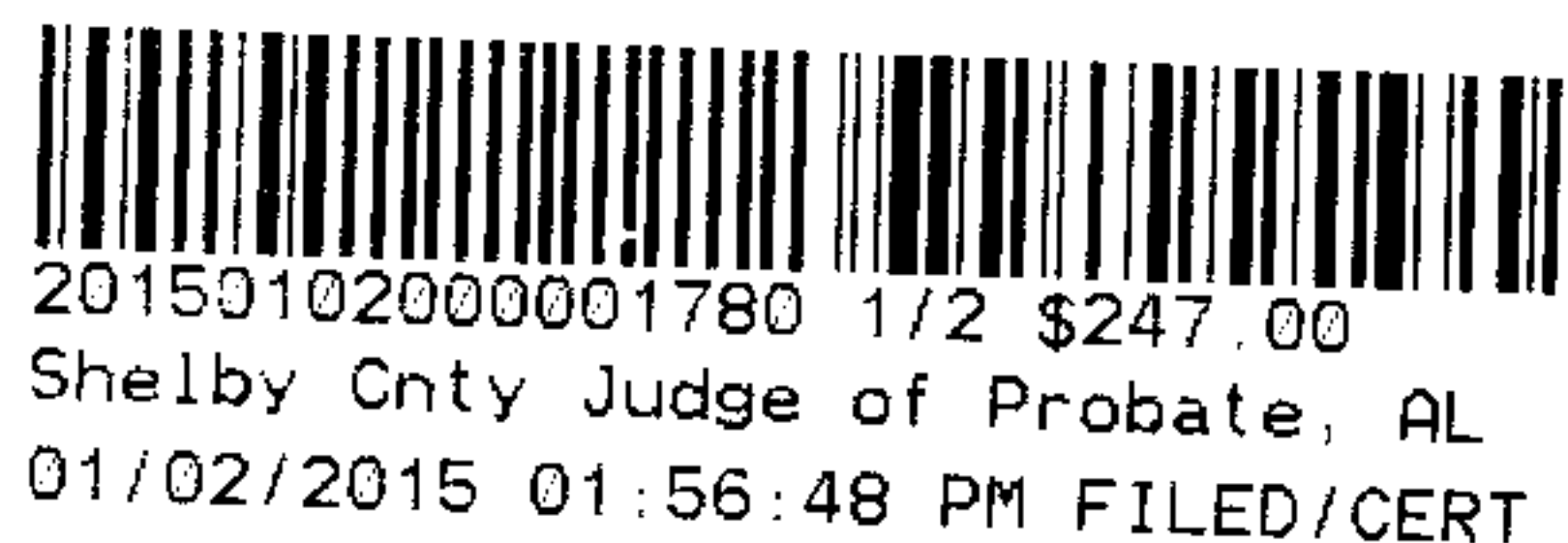

WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of Three Hundred Thirty Thousand And No/100 Dollars (\$330,000.00) paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, Jacqueline K. Hester, an unmarried woman (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto Michael M. Jones and Eleanor G. Jones (hereinafter Grantees), as joint tenants with rights of survivorship, all of my/our right, title and interest in the following described real estate, situated in Shelby County, Alabama.

Lot 12-02, Block 12, according to the Survey of Mt. Laurel Phase II, as recorded in Map Book 30, Page 10, in the Probate Office of Shelby County, Alabama; being situated in Shelby County, Alabama.

Grantor does, for Grantor and for Grantor's heirs, executors and administrators covenant with the said Grantees as joint tenants, with rights of survivorship, their heirs executors and administrators, that Grantor is lawfully seized in fee simple of said premises; that it is free from all encumbrances, unless otherwise noted above; that Grantor has a good right to sell and convey the same as aforesaid; that Grantor will and Grantor's heirs, executors and administrators shall warrant and defend the same to the said Grantees, and their heirs, executors and administrators forever, against the lawful claims of all persons.

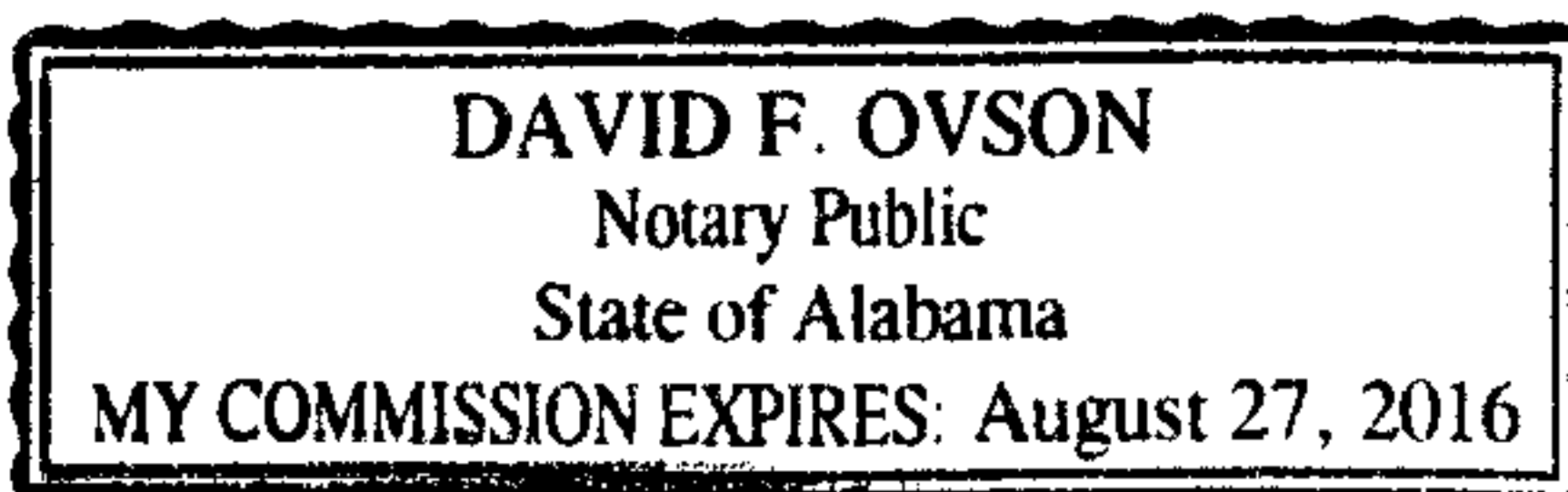

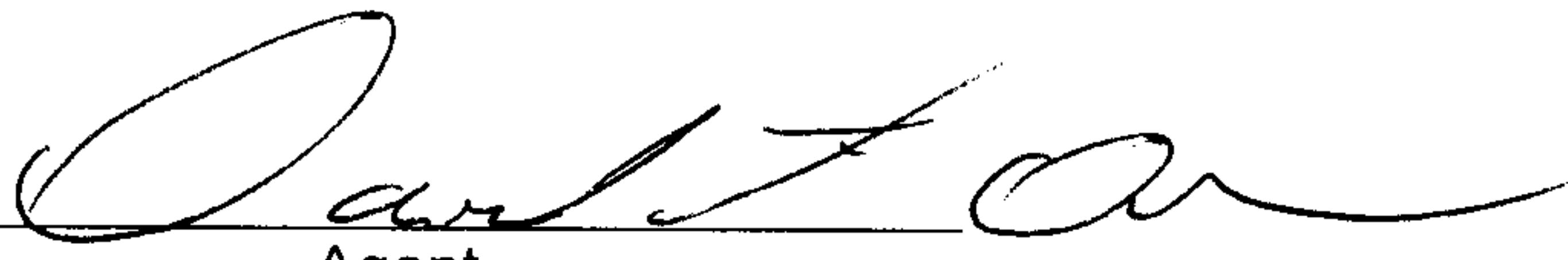
