KNOW ALL MEN BY THESE PRESENTS, that pursuant to the authority granted under that certain limited power of attorney attached as Exhibit A hereto (the "Citibank Limited Power of Attorney") by Citibank, N.A., a national banking association ("Citibank"), in its capacity as former trustee of the trusts identified in Exhibit A thereto (the "Trusts"), **Wilmington Trust, National Association**, a national banking association ("Trustee"), as successor to trustee to Citibank for the Trusts, by these presents does hereby make, constitute and appoint **Ocwen Loan Servicing, LLC** ("Servicer"), Trustee's true and lawful attorney-in-fact, and hereby grants it authority and power to take, through its duly authorized officers and designated agents, the Actions (as such term is defined herein) in Trustee's name, place and stead. This limited power of attorney (the "Limited Power of Attorney") is given in connection with all mortgage loans held by each of the Trusts (the "Mortgage Loans").

As used above, the term "Actions" shall mean performing such acts and executing such documents in the name of Citibank necessary and appropriate to effectuate the transfer of all the Mortgage Loans and related documents into the name of Trustee and out of the name of Citibank and such other documents necessary or requested by a servicer in connection with the ownership and servicing of the Mortgage Loans.

Pursuant to the power granted to it by the Citibank Limited Power of Attorney, Trustee, as Citibank's attorney-in-fact, further grants Servicer full power and authority to execute such instruments and to do and perform all and every act and thing necessary and proper to carry into effect the power or powers granted by or under this Limited Power of Attorney as fully as the undersigned might or could do under the Citibank Limited Power of Attorney, and hereby does ratify and confirm all that Servicer shall lawfully do or cause to be done by authority hereof. The undersigned also grants unto said Attorney-in-fact, subject to the foregoing limitations, the full power and authority to correct minor ambiguities and errors in documents necessary to effect the above.

This appointment is to be construed and interpreted as a limited power of attorney. The enumeration of specific items, rights, acts or powers herein is not intended to, nor does it give rise to, and it is not to be construed as a general power of attorney.

Third parties without actual notice may rely upon the exercise of the power granted under this Limited Power of Attorney, and may be satisfied that this Limited Power of Attorney shall continue in full force and effect and has not been revoked unless an instrument of revocation has been made in writing by the undersigned.

This Limited Power of Attorney shall be governed by, and construed in accordance with, the laws of the State of New York without regard to its conflicts of law principles.

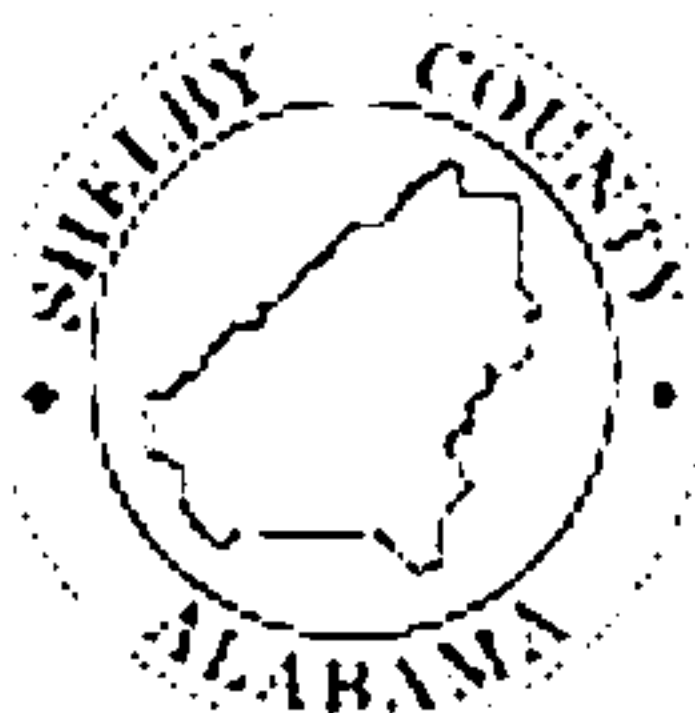
