BISCHOFF and SHANNON E. BISCHOFF, husband and wife, by and through their attorney in fact, TAD LEGAS** (hereinafter referred to as Grantors), the receipt whereof is hereby acknowledged, the Grantors do hereby give, grant, bargain, sell and convey unto the Grantees, **ABEL RYAN LUCAS and AIMEE LUCAS** (hereinafter referred to as Grantees), for and during their joint lives and upon the death of either, then to the survivor of them in fee simple, together with every contingent remainder and right of reversion, their heirs and assigns, the following described Real Estate, lying and being in the County of Shelby, State of Alabama, to-wit:

Lot 3, according to the Survey of Meadows Cove, as recorded in Map Book 24, page 53, in the Probate office of Shelby County, Alabama.



Subject to rights-of-way, covenants, restrictions, easements, agreements, setback lines, reservations, mineral/mining rights, and declarations of record, if any.




