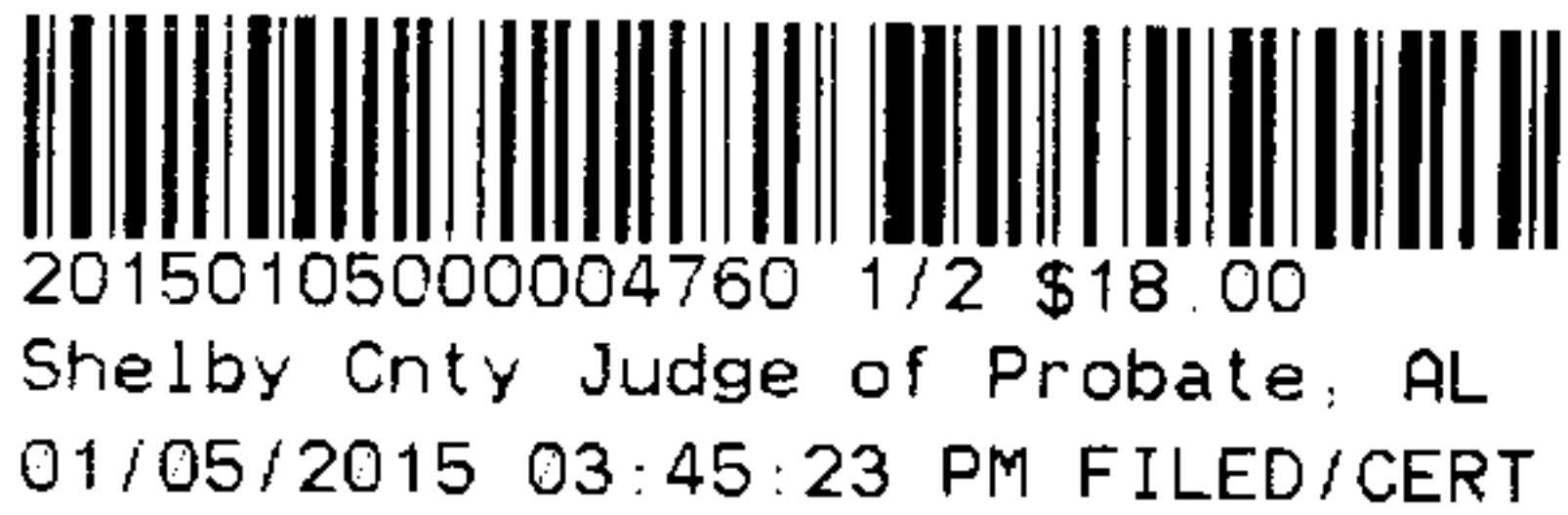

KNOW ALL MEN BY THESE PRESENTS, That in consideration of the sum of Two Hundred Thirty-Three Thousand Five Hundred And No/100 Dollars (\$233,500.00) paid by the grantee herein, the receipt of which is hereby acknowledged, I/we, James E. Call and Candis L. Call, husband and wife (hereinafter grantor, whether one or more), do grant, bargain, sell and convey unto Robert E. Bell, Jr. and Tiffany R. Bell (hereinafter Grantees), as joint tenants with rights of survivorship, all of my/our right, title and interest in the following described real estate, situated in Shelby County, Alabama.

Lot 9, according to the Survey of Indian Creek, Phase II, Sectors I & II, as recorded in Map Book 14, Page 89, in the Probate Office of Shelby County, Alabama.

Subject to current taxes, all matters of public record, including, but not limited to easements, restrictions of record, and other matters which may be viewed by observation.

Two Hundred Forty-One Thousand Two Hundred Five And No/100 Dollars (\$241,205.00) of the consideration recited herein is from the proceeds of a purchase money mortgage of even date herewith.

TO HAVE AND TO HOLD unto the said Grantees as joint tenants, with rights of survivorship, their heirs and assigns, forever; it being the intention of the parties to this conveyance that (unless the joint tenancy created is severed or terminated during the joint lives of the grantees herein) in the event one grantee herein survives the other, the entire interest in fee simple shall pass to the surviving grantee, and if one does not survive the other, then the heirs and assigns of the grantees herein shall take as tenants in common.

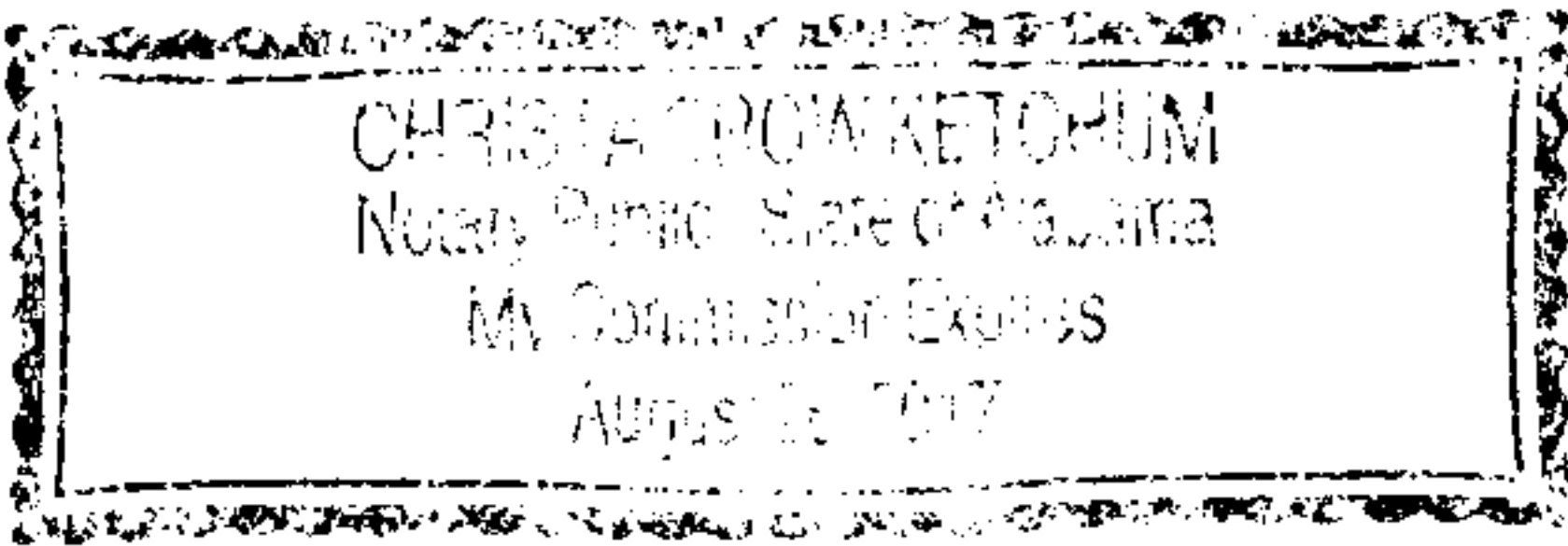
