FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on February 24, 2006, to-wit: Kevin R. Judy and spouse, Shannon P. Judy, executed a mortgage to Mortgage Electronic Registration Systems, Inc., solely as nominee for Coats and Co. Inc., its successors and assigns, herein called the Mortgagee, which said mortgage was recorded on March 9, 2006, in Instrument Number 20060309000111810, Probate Records of Shelby County, Alabama, which conveyed the property hereinafter described to secure the indebtedness evidenced by a note, payable in installments, therein described; which said mortgage was subsequently assigned to CitiMortgage, Inc., by assignment recorded May 19, 2010 in Instrument Number 20100519000156990, Probate Records of Shelby County, Alabama; and

WHEREAS, parts of said indebtedness remained unpaid at the respective maturities thereof, and the whole of said indebtedness thereupon became due and payable, and default was made in payment thereof, and thereafter notice was published in The Shelby County Reporter, a newspaper of general circulation and published in Shelby County, Alabama, on November 5, 2014, November 12, 2014, and November 19, 2014, that the hereinafter described property would be sold at the Shelby County Courthouse at Columbiana, Alabama, at public outcry to the highest bidder for cash, within the legal hours of sale on January 6, 2015, and




