FORECLOSURE DEED

KNOW ALL MEN BY THESE PRESENTS, that, whereas, heretofore on December 15, 2004, to-wit: Rod C. Ricciardi and wife, Theresa A. Ricciardi, executed a mortgage to Mortgage Electronic Registration Systems Inc., solely as nominee for Castle Mortgage Corporation, its successors and assigns, herein called the Mortgagee, which said mortgage was recorded on December 22, 2004, in Instrument Number 20041222000698280, Probate Records of Shelby County, Alabama, which conveyed the property hereinafter described to secure the indebtedness evidenced by a note, payable in installments, therein described; which said mortgage was subsequently assigned to US BANK NATIONAL ASSOCIATION AS TRUSTEE FOR CMSI REMIC SERIES 2005-01 - REMIC PASS-THROUGH CERTIFICATES SERIES 2005-01, by assignment recorded September 10, 2014 in Instrument Number 20140910000284230, Probate Records of Shelby County, Alabama; and




