KNOW ALL MEN BY THESE PRESENTS, that

WHEREAS, heretofore, on, to-wit: the 16th day of June, 2009, Miranda M. Williams, a married woman, and husband Allen Bernard Williams, executed that certain mortgage on real property hereinafter described to Mortgage Electronic Registration Systems, Inc., acting solely as nominee for Everbank, which said mortgage was recorded in the Office of the Judge of Probate of Shelby County, Alabama, in Instrument Number 20090629000250100; re-recorded in Instrument Number 20091008000381520, said mortgage having subsequently been transferred and assigned to Lakeview Loan Servicing, LLC, by instrument recorded in Instrument Number 20140905000279270, in the aforesaid Probate Office ("Transferee"); and

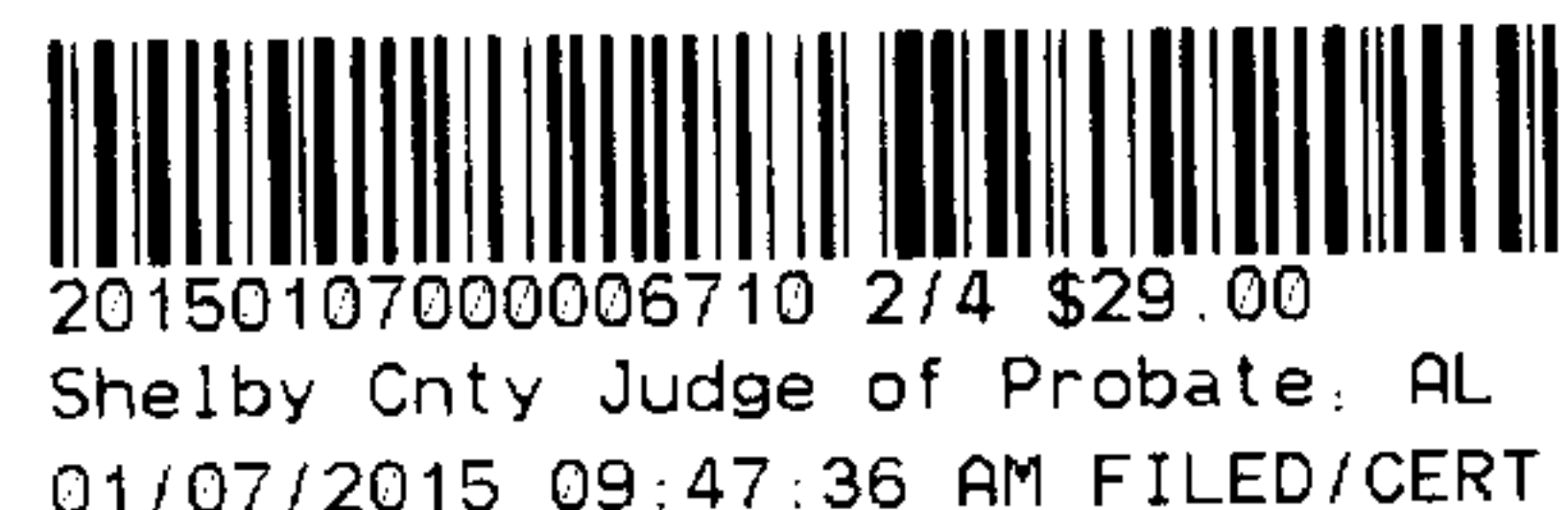

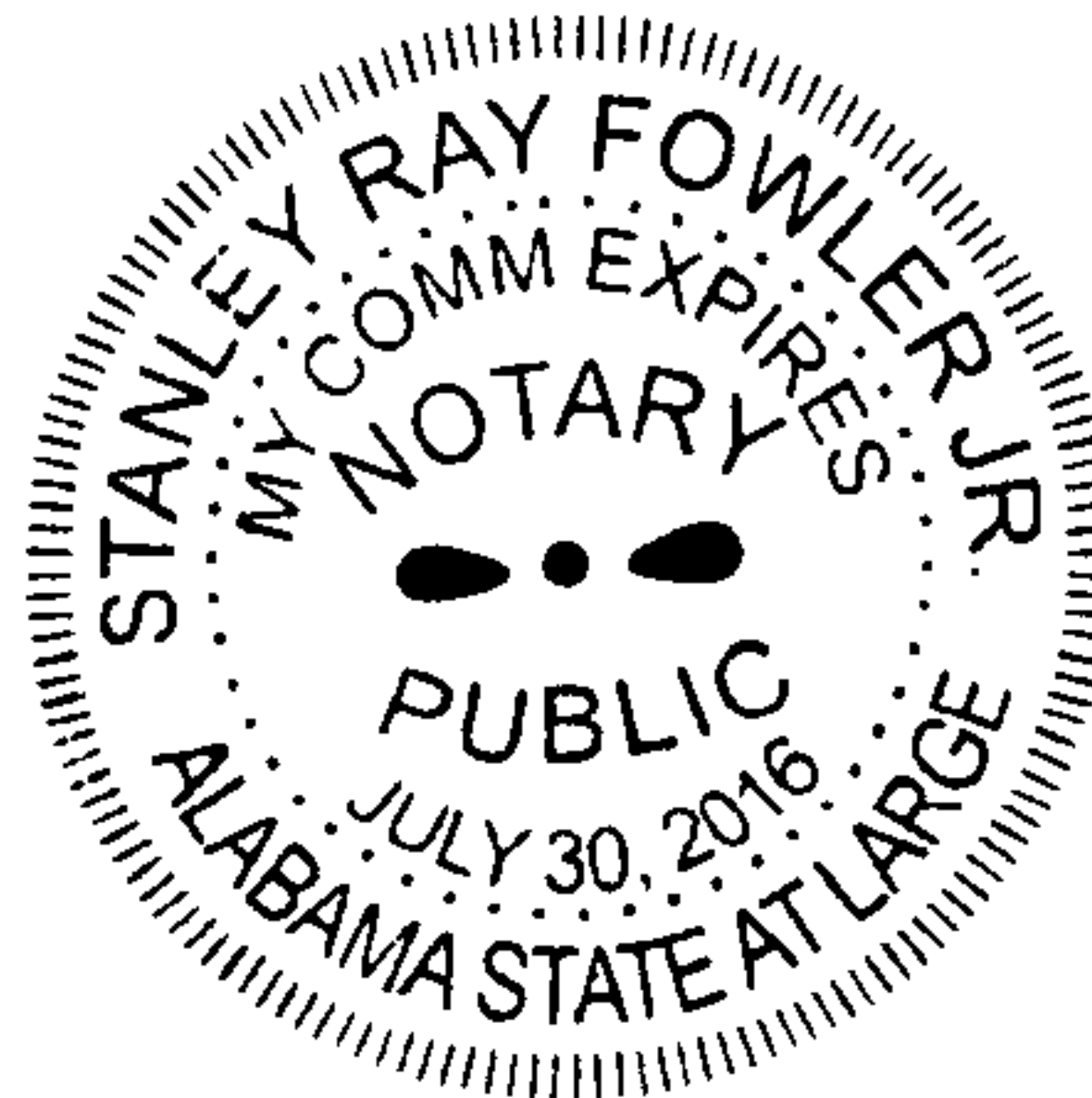
