Chad B Hunt
(herein referred to as GRANTEE, whether one or more), the following described real estate situated in SHELBY County, Alabama, to-wit:

Lot 100A, according to the Survey of Dunnivant Square Resurvey, as recorded in Map Book 42, page 123A, 123B, and 123C, in the Probate Office of Shelby County, Alabama.

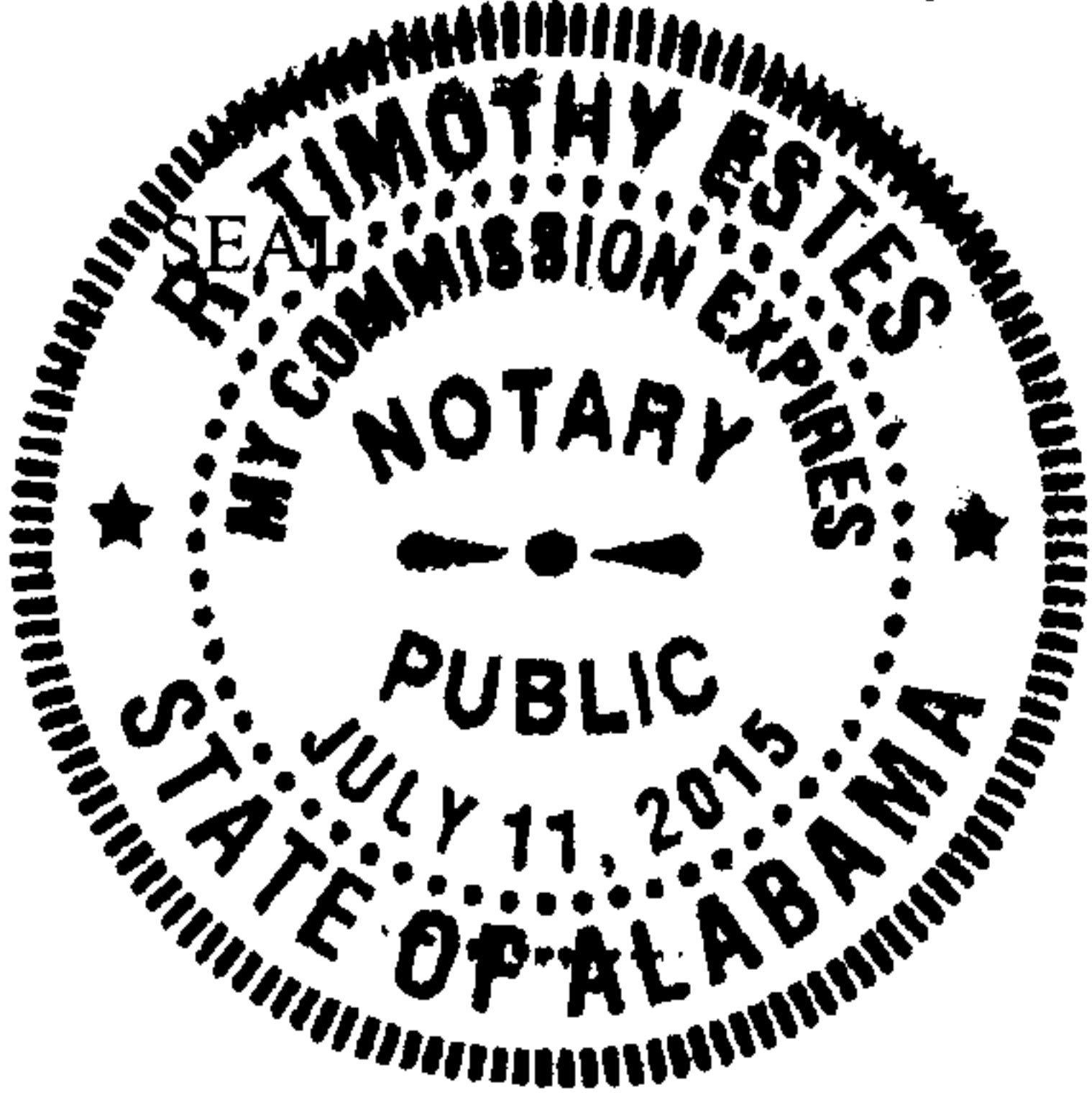

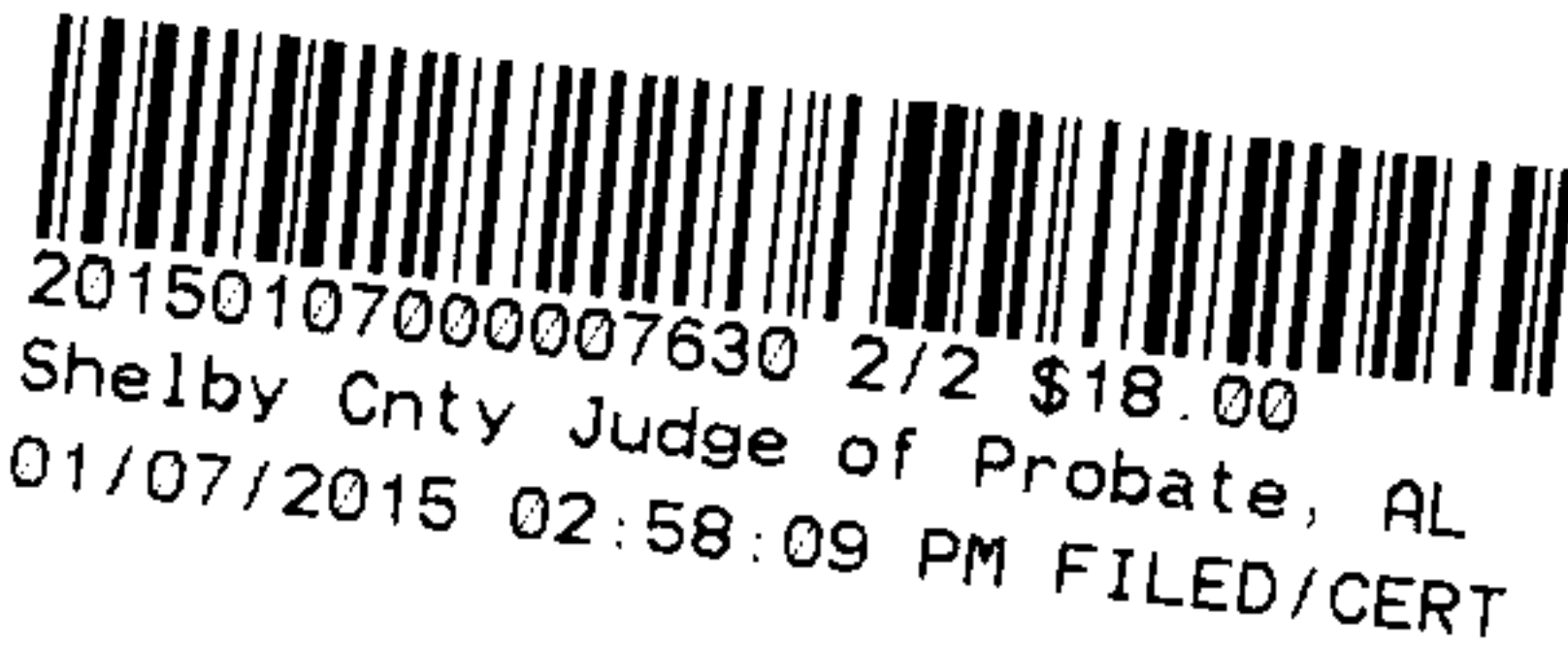
