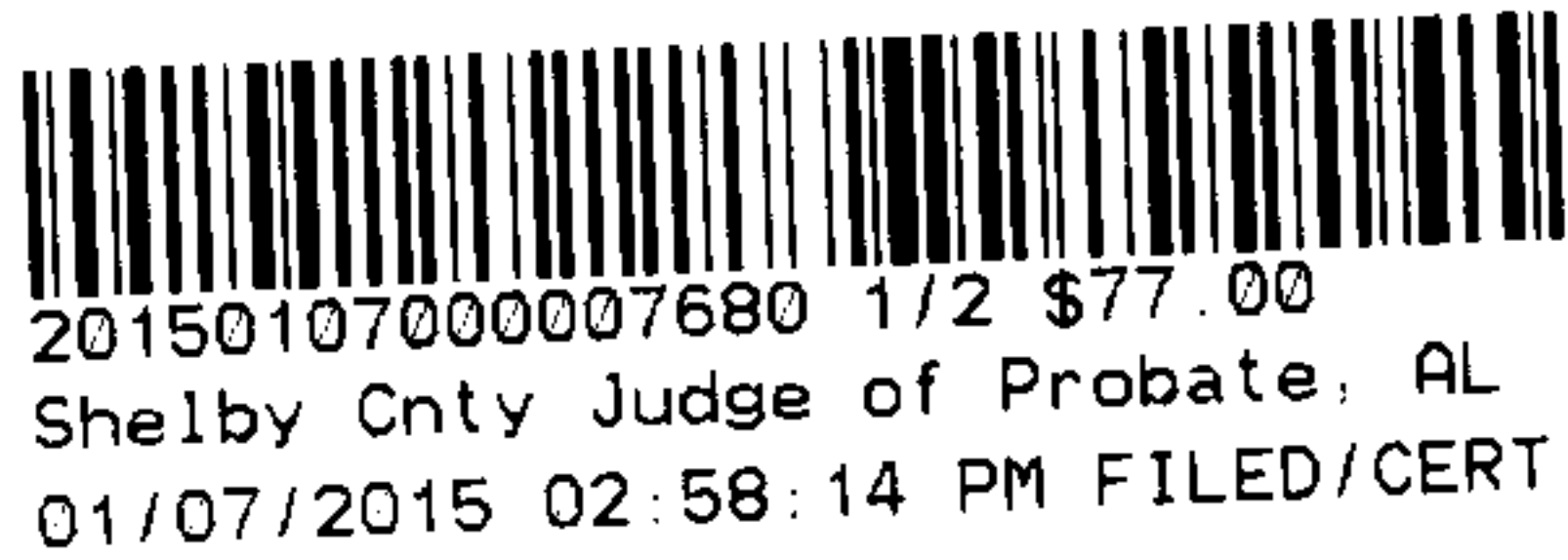

(herein referred to as GRANTOR, whether one or more) does, grant, bargain, sell and convey unto

Colleen K Rikard
(herein referred to as GRANTEE, whether one or more), the following described real estate situated in SHELBY County, Alabama, to-wit:

Lot 129, according to the Amended Map of Cottages at Chesser Phase II, recorded in Map Book 38, page 49, in the Office of the Judge of Probate Shelby County, Alabama.

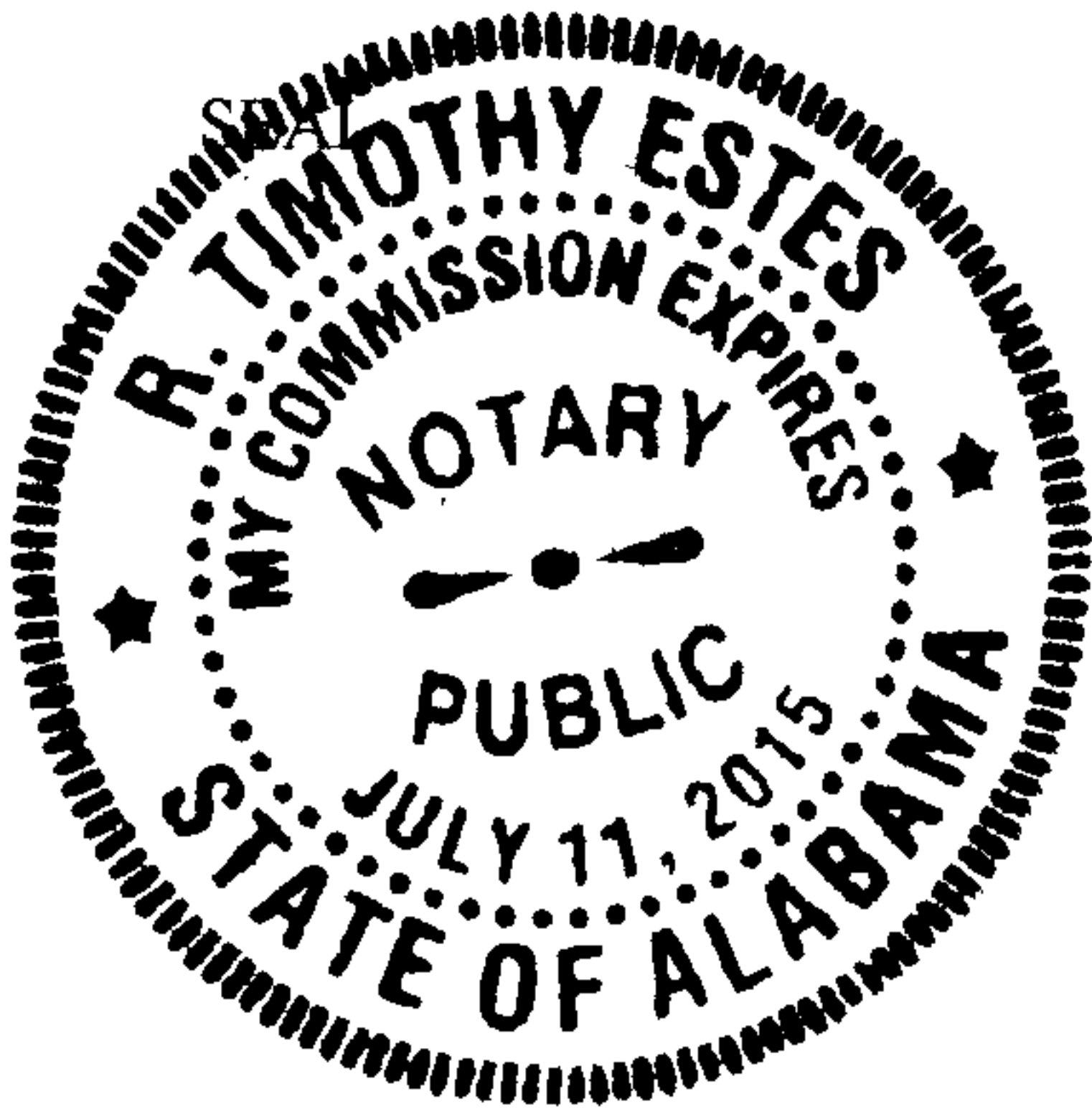
