

## AMENDED ARTICLES OF ORGANIZATION

The undersigned, Pursuant to the Alabama Business Corporation Act, the above corporation, pursuant to a resolution duly adopted by its members, hereby adopts the following amended Articles of Organization, by removing a member, and by changing the corporate name as set forth below:

1. NAME OF COMPANY. The name of the Company shall be amended to:

**"MORRISON & SPANN, LLC"**

2. PERIOD OF DURATION. The period of duration of the Company shall remain to be perpetual.

3. COMPANY PURPOSES SHALL REMAIN AS FOLLOWS. The Company purpose shall remain to be organized for the purposes of engaging in the practice of law. The Company can also within said purpose transact any other lawful business for which a limited liability company may be formed under the Alabama Business Corporation Act, but nothing herein shall be construed as authorizing the Company to carry on the business of banking or insurance or to act as a trust Company, nor shall it be construed as authorizing the Company to act as a securities broker, a securities dealer or as an investment advisor.

4. REGISTERED OFFICE AND REGISTERED AGENT SHALL REMAIN AS FOLLOWS. 
given by the original members of Crowson, Morrison & Spann, LLC, to amend the corporate name, and remove a member, to wit: Daniel A. Crowson, Jr.


