The name and business address of the limited liability company's registered agent for service of process is: Stephen R. Stricklin, 223 1st Street North, Alabaster, Alabama 35007.

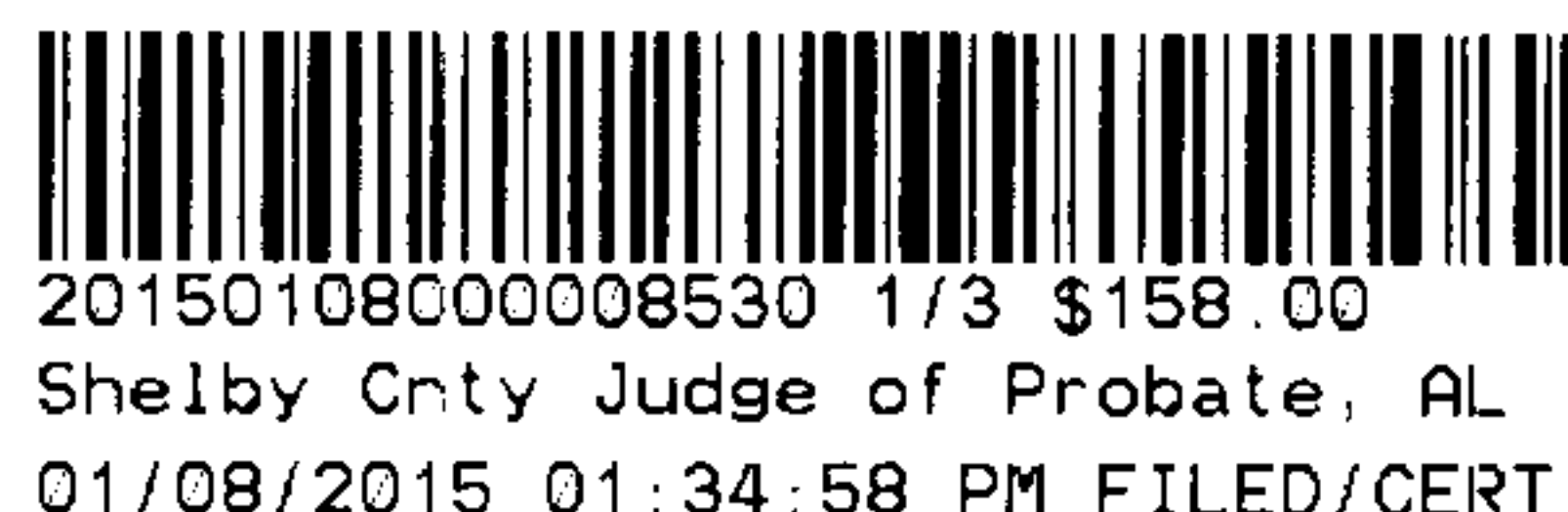
ARTICLE FIVE

ARTICLE TEN


The limited liability company shall have one manager who shall serve until the first annual meeting or until his successors is elected and qualified. The initial manager shall be:

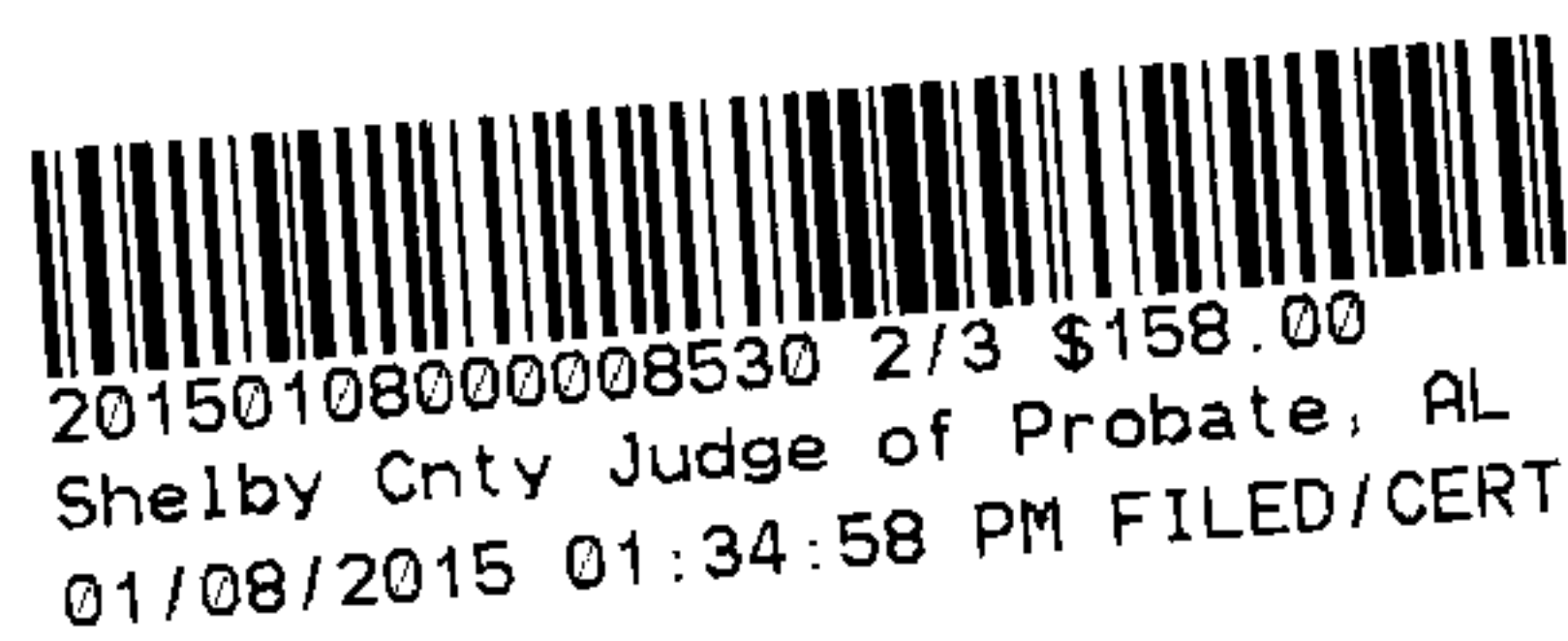
ARTICLE ELEVEN

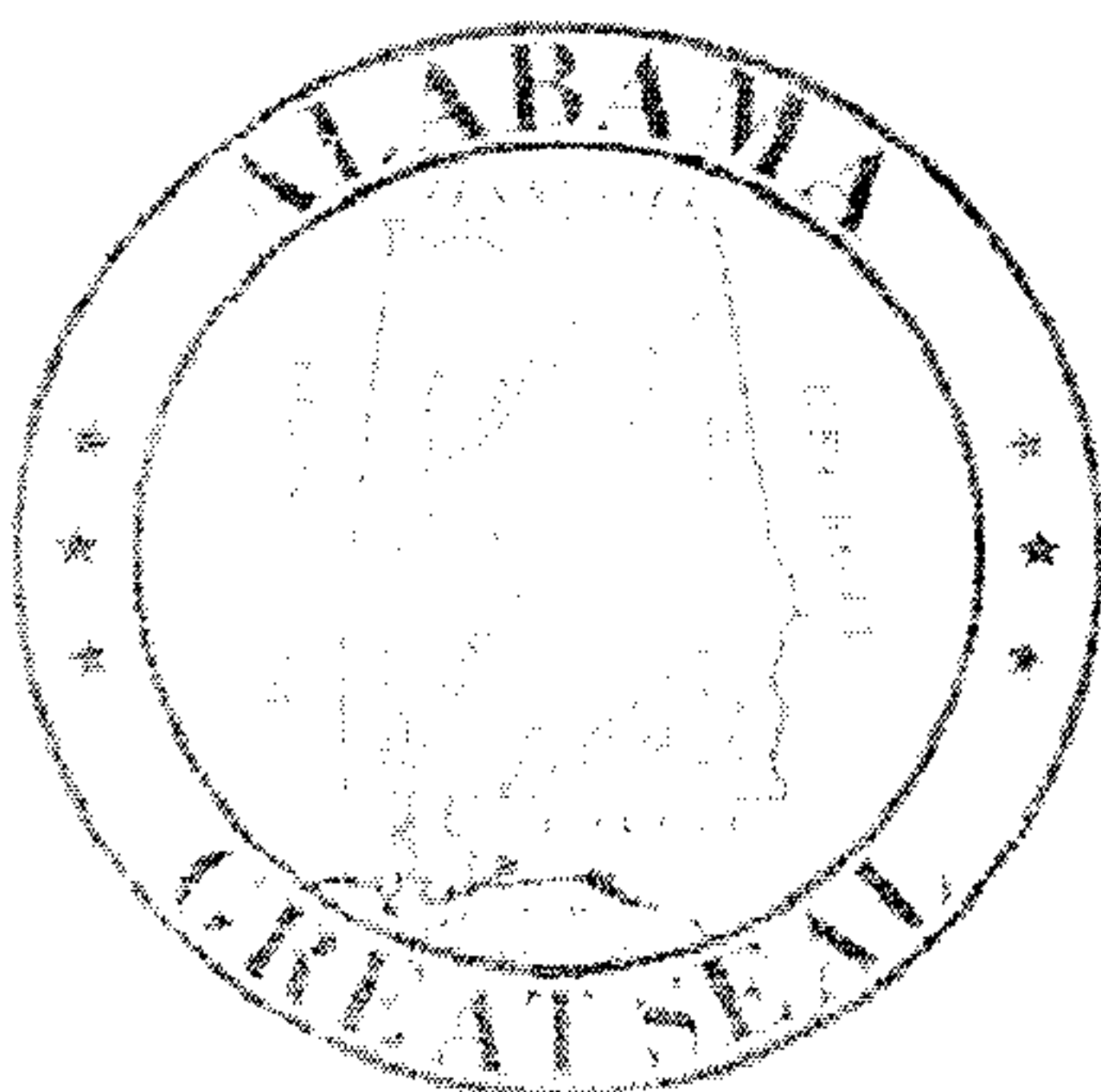
