**ARTICLES OF ORGANIZATION
OF
GOOD CENTS MOTOR SPORTS, LLC**

Desiring to form a Limited Liability Company pursuant to the provisions of Act No. 93-724 of the 1993 Alabama Legislature, as amended, the undersigned hereby adopts the following:

**ARTICLE I
NAME**

1.1 The name of the Limited Liability Company is **Good Cents Motor Sports, LLC**.

**ARTICLE II
PERIOD OF DURATION**

2.1 The term of the Limited Liability Company shall commence on the date of the filing of these Articles of Organization in the Office of the Judge of Probate of Jefferson County, Alabama, and shall terminated and dissolve (a) upon the death of the Members; or (b) termination by the Members in their sole discretion.

**ARTICLE III
PURPOSES AND OBJECTIVES**

3.1 To operate, conduct, and maintain a business and to transact any or all other lawful business for which Limited Liability Companies may be organized under the Alabama Limited Liability Company Act.

**ARTICLE IV
REGISTERED OFFICE AND REGISTERED AGENT**

4.1 The location address of the initial registered office of the Limited Liability Company shall be PO Box 361094, Hoover, Alabama 35236.

4.2 The name of the initial registered agent of the Limited Liability Company shall be Mr. Jarrett Frye.

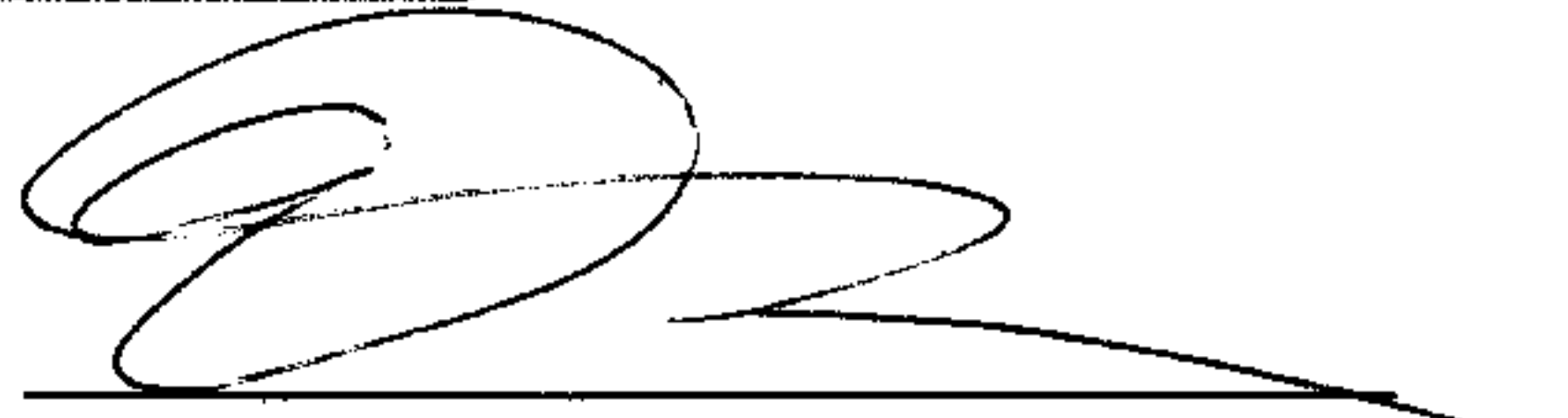

ADDITONAL MEMBERS**
