Know All Men by These Presents: That in consideration of **Three hundred eighty seven thousand thirteen dollar and no/100 (\$387,013.00)** to the undersigned grantor (whether one or more), in hand paid by the grantee herein, the receipt where is acknowledged, I or we, **Jebco, Inc.** (herein referred to as grantor, whether one or more), grant, bargain, sell and convey unto **James L. Jones and Delpha Bartley Jones** (herein referred to as grantee, as joint tenants with right of survivorship, whether one or more), the following described real estate, situated in **Shelby County, Alabama**, to-wit:

**Lot 14, according to the Final Plat of Sterling Gate Sector 2 Phase 2, as recorded in Map Book 36, Page 86, in the Probate Office of Shelby County, Alabama.**

Subject to mineral and mining rights if not owned by Grantor.

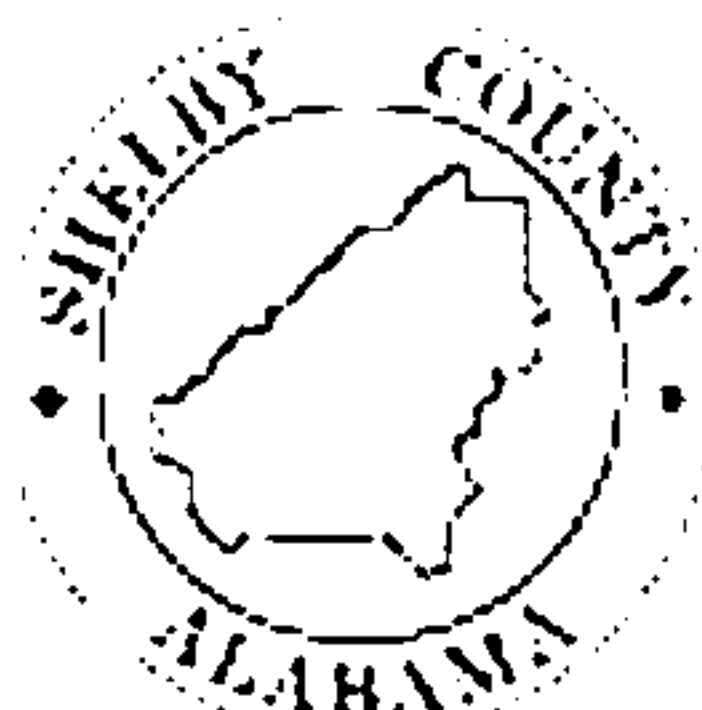
