ORDER TO APPROVE COMPROMISE AND CONSENT JUDGMENT

The Settlement is submitted by the parties and approved and Judgment is entered in favor of the Plaintiffs in the amount of \$50,000.00. That said Judgment is nondischargeable. That said judgment is non-executable for a period of five years. Further, if Defendant pays a lump sum of \$25,000.00 within 5 years from the date of this order, then the judgment shall be deemed satisfied.
